**MCA Wamba North ward, (Hon. Christopher Lentukunye):** Thank you Hon. Speaker, I stand to table a policy paper on the establishment of the County Liaison Office in Nairobi.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** On this policy paper, I refer it to the Committee on Delegated Legislation.

## **STATEMENTS**

### **Statement on Street lighting in Maralal Town.**

**MCA Elbarta Ward, (Hon. Romano Leakono):** Thank you Hon. Speaker, I rise to inquire on the statement which is due from the Chair for Roads and Public Works, Hon. Lentukunyei.

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):** Thank you Hon. Speaker, before I table my response on the statement raised in this House, I wish to enquire whether it is in order to give the response when it is not in the order paper,

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** I think it is in order because it has to be today. I remember that you insisted that it would not be another day, it has to be now. So, I am just wondering, Hon. Chair, whether you forgot about that response?

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):** Mr. Speaker, thank you for your direction. The response is available in this House but I do not have it here.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Just have your seat Hon. Leakono. Hon. Chair, I want you to be serious on this subject, because if you say that it is within the premises of the House, does it mean that you have circulated the response or have you delegated any

Member to answer it on your behalf? Or if the statement is not ready, you should just state that it is not ready and tell us when it will be ready.

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):** Mr. Speaker, the response is ready and you can request the clerks to circulate copies because, I believe, they are ready.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Okay, clerks give the Chair the copies so that he would be able to answer. Did you sit as a committee or as a Chair?

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):** We did not sit as the committee but the statement was prepared by the CEC and I believe that it is within this House.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Chair, we just do not speculate. It is upon you to have it with you. I will give you up to Tuesday next week to answer the statement but you have to be serious, because it seems you are not particularly sure which clerk you had given it to. Which clerk did you give to?

**MCA Maralal Ward, (Hon. Elly Loldepe):** Thank you Mr. Speaker, I am just rising on the concerns which we had on that particular day. The department is trying to delay this because the reasons to do justice to the people and those budgets are there and those are our concerns. It is an evasive tactic and they keep on evading and this is almost the seventh time and it is unfair to the residents.

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):** Thank you Hon. Speaker, I beg to give my response to the statement number 30 from Hon. Elly Loldepe, regarding the street lighting in Maralal town. The department has over the last year embarked on lighting streets in Maralal town and to date, a total of 25 kilometers has been covered. Street lighting is a relatively expensive project and the department has failed to secure adequate funding for the exercise due to need for other services in the County. The street lighting

exercise started from the CBD and now it is extending to cover the estates such as Milimani, Upper hill, Cereal board, Loikas, AIC and Loresho. The department intends to budget for street lighting every financial year until all areas are covered. It is important to note that informal settlements or high density areas such as Loikas require flood lighting as opposed to street lighting and this will cost approximately Ksh 1.1 million per mast covering a radius of 300 meters. In addition, we have written to the Department of Lands to fast track the demarcation of roads in the said areas to enable the department to identify official roads for street lightings.

**MCA Maralal Ward, (Hon. Elly Loldepe):** Thank you Mr. Speaker, looking at this response, our concerns has not yet been addressed. And this was the exact response brought some time back which this House actually said no to. I do not know whether the Chair is aware what Loikas looks like a slum so that they call it an informal settlement, although the perception of the people is that Loikas looks like a slum while it is not. There are very big roads within those areas. I wonder in what case they are calling it an informal settlement. There are plots and demarcations except Loikas primary school where they said that they have written to the department. It is just about the primary school and not the entire Loikas area. The letter they are talking about was done to make for a road around the school. It is not about the roads in Loikas. I think that putting this as a basis and now that it is about a very small area around the school is completely misleading this House. I had raised the concern of creating a class kind of society in our development. The department continues to view other areas as slums even when all the other things are there. Those people are paying rent for the lands that they are occupying to the County because there are plots. So, I am wondering what other kind of roads they want other than the existing ones. The statement is misleading because one of the things that we will require the department to do with the Chair and his committee is to visit the place and find out whether there are roads or not. Instead of tabling a statement that is misleading from people who do not want to do that which, I think, will be a disgrace to this House yet we know that continuing to present what we know is wrong. So, I request the committee to visit the area and see the big roads that are there. I know that some of them have even visited the area and they should take an appropriate action because I think that this is misleading, thank you Mr. Speaker.

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):**

Thank you Mr. Speaker Sir, I rise to comment on the report from the Hon. Chair and being a Member of this committee I think that it is prudent for us to know or to understand what is happening. Because, I do not have a copy here and if I remember what the Chair said, the response contains the areas covered and the areas that are in plan. We all know the kind of budgets that we passed and we know the constraints based on finances. I believe I heard them saying that there are areas under the process. Milimani or Loresho, AIC, and I think that is starting from a point. I do not think that it necessarily mean that it can start from point A. I think that if the ministry agrees with the budget and their plans to do that, we do not need to visit Loikas because we know the place and we even own plots there. So, we know how it is and when some departments say that the roads are not very clear and they have contacted the right department to specify the roads so that they can go ahead and plan, I do not see the need of the committee to go ahead and visit there. We should wait and let the department pursue their projects and when they don't, and then the Hon. Member has the right to come back to this House or to get the committee so that we visit the community, thank you Mr. Speaker Sir.

**MCA Baawa Ward, (Hon. Pius Lobuk):** Thank you Mr. Speaker, having heard the statement which gave us the plan of this lighting, to me this statement sounds biased. We have a concept in social work called social stratification which is the division of human beings according to their economic status. There are upper, middle and lower classes. According to me, the lighting is based on that concept.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Order Hon. Lobuk, which lightning are you talking about?

**MCA Baawa Ward, (Hon. Pius Lobuk):** The street lighting.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Okay, I heard lightening.

**MCA Baawa Ward, (Hon. Pius Lobuk):** Thank you Mr. Speaker. About this lighting, I have a problem with that pronunciation but it is biased in a way. When you approach the CBD, you

could clearly see that one part of CBD is fully covered while the rest of the place is dark. Everything here is totally biased. Milimani is fully covered with the lights and some parts of the CBD. If you could see Loikas, Shabaa, Loresho and all those areas, they are totally dark. I think that we could have touched each and every part when we do this kind of service. I would like to inform the Hon. Chair that there is that problem and we are seeing biasness being done upon the residence of this town which needs to be rectified as soon as possible. We even know those who live in Milimani and those living in Shabaa. This is clearly stated that the place is fully covered. Street lights would go up to someone's entrance but I can't mention them now but later.  
*(Laughter)*

**MCA Nyiro Ward, (Hon. Jonathan Lemoosa):** Thank you Hon. Speaker, I stand to give my opinion on something personal but... *(Interrupted by the Speaker)*

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Order Hon. Members, Hon. Lemoosa is on the floor.

**MCA Nyiro Ward, (Hon. Jonathan Lemoosa):** I stand to give my personal perception basing my knowledge on the direction of the paper or the statement. Just as my colleague Hon. Lelenkeju has said, any job has to start at a particular point... *(Applause)*, I really don't know if we have classes in Kenya as it is in India where it is official. This depends on how you perceive one's status. What I want to believe here is that the executive laid down some starting point and maybe eventually covering the CBD of Samburu County. Nevertheless, Members raised concerns that maybe it started from point A whereas it should have started from point B. Which do not give you any logic on where it starts and eventually end. The sub-point of this will be and should be the CBD should actually be covered by the street lighting. Our role is oversight and we need to give some patience to the executive knowing that the result envelop is not enough and there will never come a time when the need/finances will ever be at an equilibrium. Let us appreciate the fact that Maralal CBD is actually giving some light and life to our residence. Let us not look at the point whereby I perceive for example just because Lemoosa lives there means that Lemoosa is a class higher or lower. Because, I do not know what parameters we use when

we start putting ourselves into such social status. Let us appreciate this and be patient and let the executive work and we give guidance where necessary. But we need to give guidance and say that this is where it should have started or otherwise. I want to believe that sooner or later Maralal will be covered with street light, Thank you Speaker.

**MCA Elbarta Ward, (Hon. Romano Leakono):** Thank you Hon. Speaker, I just want to put in some input on the issue of the Maralal lighting. Obviously, it has to start from a point and end somewhere. I actually echo the CEC for Works for actually having started from maybe the left depending on where we are facing. If you are starting from the left and planning to finish on the right hand, because I believe that the Hon. Member is not *(inaudible)* But the Hon. Member chooses where he lives...that the project is progressing towards the right side of the town facing North. Therefore, the Hon. Member maybe has to be patient, because the lighting is also going to *(inaudible)* very soon. That is what we have been told by the CEC. Lastly, the Hon. Member is actually the representative of all these places that have been mentioned, and since we are using money... *(Interrupted by the Speaker)*

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Order Hon. Leakono, we are not discussing about the Member here but the statement. Just discuss about the validity of the statement.

**MCA Elbarta Ward, (Hon. Romano Leakono):** Sorry for the error but I just wanted to say that the Hon. Member is representing the whole of Maralal town and the residents of the places where the lighting is covering like Upper hill or Milimani. They are all his residents. Let us be patient because we are using the wiring and you cannot disconnect wiring from this end to another end because we are using one bill or one meter. I believe that it is progressing towards Shabaa, Loikas and Loresho. I just beg the Hon. Member to understand and give the CEC a chance to light our town because Yare is even part of it. In fact, I think somebody has been talking about Yare because it is also within Maralal town. Thank you Hon. Speaker Sir.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Thank you Hon. Members, lastly Hon. Loldepe.

**MCA Maralal Ward, (Hon. Elly Loldepe):** Thank you Mr. Speaker. Just to give some clarifications, I do not know whether hon. Members were here when we were debating. It is very clear and my brother Hon. Lobuk had actually put it very well that the statement actually puts the society into social strata. We object that we need a society that is created on social status, that you get services based on the kind of clothes that you wear, what kind of car you drive and what kind of house you live in. I think that that is the injustice that we say no to and we will still remain opposing. We object to putting other areas that are fully planned with roads as informal settlement, a social classification. Secondly, I had raised the concerns that way Mr. Speaker.

**MCA Elbarta Ward, (Hon. Romano Leakono):** Point of order Hon. Speaker.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** What is the point of order Hon. Leakono.

**MCA Elbarta Ward, (Hon. Romano Leakono):** Is it in order for the Hon. Member to say that the CEC or the County Government of Samburu is actually working on dividing the people of Samburu County as rich and poor? If yes, can he substantiate? Thank you Hon. Speaker.

**MCA Maralal Ward, (Hon. Elly Loldepe):** Yes Mr. Speaker and I can substantiate by reading paragraph two on the fourth line where it says that it is important to know that informal settlement of high density is...*(interrupted by Hon. Leakono)*

**MCA Elbarta Ward, (Hon. Romano Leakono):** Point of order

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Order Hon. Leakono, I think that you requested the Member to substantiate and that is what he is doing and you are not giving him time.

**MCA Elbarta Ward, (Hon. Romano Leakono):** I was asking with all due respect that...  
*(Interrupted by the Speaker)*

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Order Hon. Leakono, continue Hon. Elly.

**MCA Maralal Ward, (Hon. Elly Loldepe):** Mr. Speaker maybe my brother should learn English because it is simply stated.

**MCA Elbarta Ward, (Hon. Romano Leakono):** Hon. Speaker, Is it in order for the Hon. Member to use abusive language?

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** That is not in order. Hon. Elly can you withdraw and apologize.

**MCA Maralal Ward, (Hon. Elly Loldepe):** Mr. Speaker just to clarify, I was using the word English because an informal settlement is a place which is... (*Interrupted by the Speaker*)

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** What is it Hon. Lemoosa, have your seat Hon. Elly.

**MCA Nyiro Ward, (Hon. Jonathan Lemoosa):** Thank you Speaker Sir. I still insist on the Hon. Member using belittling language or adjective to describe a Member in this House.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Is it in respect to whether the Member understands or not, Hon. Elly can you apologize.

**MCA Maralal Ward, (Hon. Elly Loldepe):** Thank you Mr. Speaker, I apologize and withdraw in terms of English, but the department needs to put it very clearly.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Order Hon. Lentukunye and Hon. Leakono.

**MCA Elbarta Ward, (Hon. Romano Leakono):** Mr. Speaker I think that the Hon. Member actually used some wrong words. I do not know whether it is in order that is purposely directed at me. I think that he should also withdraw.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Continue Hon. Elly,

**MCA Maralal Ward, (Hon. Elly Loldepe):** Thank you Hon. Speaker, maybe to substantiate what Hon. Leakono needed was whether the Samburu County Government has classified people and I replied yes. This is in paragraph 2 which is in the fourth line which starts at, ‘the department intends that it is important to know informal settlement areas such as Loikas require flood lighting’. Loikas is not an informal settlement, it is well planned, there are roads and everything is within that area. So, it cannot actually be classified as an informal settlement. Just because of the people who live there is the actual reason the department calls it an informal settlement. That is social classification and it is a fact that cannot be denied unless somebody with very clear justification shows me how. Secondly, I raised the concern that the greatest human traffick in Maralal is in Loikas area and Maralal cereals board. Just because these people are charcoal burners they cannot access lights. It is because of their class that they are still being called informal settlement. That is class and that is what the department is doing. It is very evident that the street lights that have already been done go into people’s houses, houses that people drive into and even into houses that have not yet been completed in terms of construction. That is classification that depends on who you are to access the street lights. We cannot live, think and put our eyes some kind of fold so that we cannot see. I think that most of us Hon. Members live in Milimani and they are comfortable driving cars and escorted by the street lights and the car lights. I think they are comfortable that is why they cannot even speak to that which is an injustice to their people. We cannot continue supporting injustices forever. It is an injustice.

*(Interrupted by the deputy Speaker)*

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Order Hon. Leakono and Hon. Lentukunye, you are persistent to talk when the Member is on the floor. I give you the last chance and if you continue talking I will call the Sergeant-at-arms. Continue Hon. Elly.

**MCA Maralal Ward, (Hon. Elly Loldepe):** Thank you Mr. Speaker. As I was saying, injustice anywhere in Samburu County must be spoken about. I think this is who we are, why we are here

and why we are called Hon. Members. This is because we carry the mandate of the people and if the mandate and trust that has been given to us is sold or we give it up, then I think that will be an injustice, the highest form of injustice that we can ever have. Thank you Mr. Speaker.

**MCA Nyiro Ward, (Hon. Jonathan Lemoosa):** Thank you Speaker Sir. I just want to make it clear that I am actually not opposed to the words of the Hon. Member who represents Maralal. He has the privilege and mandate and it is his oversight role. But at times we need to ask ourselves so many questions when it comes to literature or writing. I do not believe that Samburu County Government tends to put people into classes. It is only in India that I know there is such because constitutionally, all Kenyans are equal and that they have the right to all that pertains to their privileges. It is sometimes good to note when we argue that we base our issues on other matters like when we say informal settlement, in what form do we want to understand informal settlement. Because in English something that is informal is something which is maybe not really within the laws, or some acceptable modes. We may be having other ways of maybe describing something like we have the Lands Adjudication department. So, could the Member put up some evidence to show that this is what he is saying and that this is formal and informal other than just giving us the grammatical English understanding of the two words? It is true that a few Members of this House live in Milimani. But I am sure that you could see that Milimani is not fully covered by the lights and this is why I said that there is actually a reference point of starting and ending a particular activity. My argument is based on availability of funds which is actually meagre than the needs that I said before. So, if Milimani is the starting point and maybe Yare or Loresho or just somewhere else is the end point, somewhere has to be a starting point. It is unfortunate that he started in Milimani. But I think for Samburu County development, this is fortunate that this had to start somewhere and it started in Milimani. We should applaud the department of roads for doing that and starting at that. If for example we could argue and say that the lighting started in this place called the highly populated areas or the informal settlement...

*(Interrupted by the deputy Speaker)*

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Order Hon. Members. You are turning the House into a discussion ground.

**MCA Nyiro Ward, (Hon. Jonathan Lemoosa):** But I want the exact name of the place.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Hon. Lemoosa, you do not turn and ask fellow Members in the House.

**MCA Nyiro Ward, (Hon. Jonathan Lemoosa):** Loikas. If supposedly this street lighting started in Loikas, would the habitats of Milimani, Yare, Changaa or Loresho complain? Sometimes let us not fuel some kind of perception just because some good work has started somewhere. I totally agree and I will never be convinced otherwise that this lighting project started giving classes to people. It started in Milimani but, unfortunately, it did not fully cover the whole of the Maralal CBD. That is the beauty about it, Thank you.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Lastly, I give Hon. Lelenkeju to say something concerning the statement that has not been discussed because we have a bill in front of us and it will take a lot of time.

**MCA Wamba East, (Hon. Jackson Lelenkeju):** I will go by your advice and I will be very brief with a lot of respect to my colleague Hon. Elly Loldepe. We have been living in his ward for quite some time and we thank him for hosting us here and I believe that he will continue to do so for many years to come. You argue about your town and this is a resource that you have while some of us do not have. We have Archers (Post), Baragoi and other mushrooming towns and I am glad that this House considerately allowed you being a Member hosting us in the headquarters to have several projects costing a lot of money that we don't have. Road tarmacking goes for over Kshs.300 million and we have lighting, water, storm water management, drainages and the rest. This is a lot of money that other wards do not have and will never get. I think that it leaves a lot to be desired. A Member has plenty and it is only a matter of where to start and that is not a priority. I am saying that when can I have mine and yet for you it is a matter of why start

on point C and not D. All that is happening is happening in your ward, the rich and poor depend on you for representation and oversight; a role that you should do adequately without bias. It is you that want to be biased to them. Please do not, Thank you Mr. Speaker Sir.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Lastly Hon. Lorunyei.

**MCA Nachola Ward, (Hon. Lawrence Lorunyei):** Mr. Speaker Sir, Hon. Elly said that he was not satisfied by the statement because of the concerns of the people. There is no right given to him that the concern of the people will be done like this because the same response was done before. It is obvious that when you go to Maralal town, everybody's concern is for the Hon. Member to bring to this hon. House and for the hon. House to give a way forward on how the concerns will be addressed. As the statement is being read, to say that informal or that the area was not demarcated, this is his ward which is demarcated and everything is properly placed because it is a small town. I seek your direction because the response to the statement was not sufficient and when will the full information be given so that the concerns of every resident of Maralal will be addressed? Thank you Mr. Speaker.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Okay, I think I will rule on this statement. I have heard your deliberations and it is good that when we discuss as a House, we should focus on the subject rather than shifting blames to each other. Secondly, I think that most of us forgot that when this statement was being sought, I remember that there was a lot of insecurity along the Cereal road and Loikas. Even some deaths were reported. In terms of priority to put lightings, it should be based on the security of the people and also the population. That was the big concern of the Member when he requested the statement. I think that there was also an oversight on the side of the CEC when he reported that Loikas is an informal settlement. This area was planned back in 1994 which is a long time ago. It happened that I applied for a plot and I got plot number 399 and the area is well planned with very big roads. For an area which is planned, it is hard to put the mast. Mast is whereby you have a big village where people concentrate. When you put one here and the other far place then the rest will not have lights. I

think that maybe the CEC wanted to say that Milimani is not an informal settlement because you remember that it was just recently that the request was brought for the House to approve the adjudication of Milimani. Most areas in Milimani are still under construction in terms of roads and is still being planned. My proposal and rule is that let the Committee for Roads meet, visit the areas and make analysis on how the area have been planned in terms of insecurity and the people who have been burning charcoal where some were killed. I remember, it was reported here and it is also very easy instead of bargaining a lot. Let the committee write minutes, report and take to the CEC for Finance. He will be able to get the request and when the budget process comes during supplementary budget, then the Member representing Maralal can also request the CEC and the House to approve for street lighting instead of mast. I think that can save the situation, thank you.

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):** Thank you once again Mr. Speaker. I once again want to give my response to statement number 36 from Hon. Romano Leakono concerning the Baragoi street lighting. The department has budgeted Kshs. 6 million in this financial year to install street lights in key streets in Baragoi town. It is in the public domain that the National Treasury delayed this year's allocation to the Counties and this affects the implementation. We are hopeful that we will implement these projects in January 2016, thank you Mr. Speaker.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Thank you Hon. Chair for the response. What is it Hon. Lentukunye?

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):** Mr. Speaker I have another statement.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Okay, continue.

**Chair for Committee on Roads and Public Works, (Hon. Christopher Lentukunyei):** Thank you Mr. Speaker. I stand to give response to statement number 40 from Hon. Benjamin Leitore

regarding the *El-nino* damages. It is true that there is massive destruction of roads not only in Wamba West but also in other parts of the County. The department is yet to secure funding for the *E-lnino* and we are working closely with the Office of the Governor to see the possibility of securing anything from the county contingency funding towards the same cause. In the case of failure to secure the *El-nino* funding, the department is ready to start some (*inaudible*) in the current budget to accommodate the costs and accommodate the *Elnino*. This will however be in the supplementary budget that will also be briefed by the Hon. House, thank you Mr. Speaker.

**MCA Nyiro Ward, (Hon. Jonathan Lemoosa):** Thank you Speaker Sir. I rise with a lot of concern on a statement that I asked on Maralal Energy Limited Company that has activities in Nyiro and so far I am not aware of. I seek your direction and indulgence on what is happening with that statement, thank you Speaker Sir.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** To which department did you direct it to?

**MCA Nyiro Ward, (Hon. Jonathan Lemoosa):** The department of Lands.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Okay, I can't see the Chair for Land but I can see Members of the committee. Hon. Statian and Hon. Lobuk give us any information because this was given to your committee.

**MCA Baawa Ward, (Hon. Pius Lobuk):** Mr. Speaker, as per the statement sought, I was not in and I don't know about it.

**The Deputy Speaker, (Hon. Adamson Lanyasunya):** Okay, I will allow Hon. Lobuk to contact the Chair and set the meeting so that committee can follow up. The clerks tell me that it has been presented to the department. Hon. Lobuk, make a follow up.
