**The Minority Leader,** (Hon. Leleruk James): Mr. Speaker, I rise to request for more time because I have not received any statement response from the Office of the County Secretary and I request this House to give a reminder, I promise that I will probably bring the report next week, thank you Mr. Speaker

**Specially Elected MCA,** (Hon. Lenamatiyio Silapia): Thank you Mr. Speaker, I stand here and I also thank God that I have witnessed today in the morning when you ruled that the response be brought to this House at 2:30 PM, but what we are hearing is too shameful that there is no any response. I even told you that time that how sure am I that I will get that response and until now we have not received that response.

I do not know what will be you ruling on this matter because it is taking so long for the concerned to respond to a simple statement we asked for. Hon. Speaker let me read again what we inquired from the concerned I do not know if it is a Department or an Office; but these are the question:

- 1) Why did the County administration not take immediate action to address this issue?
- 2) Why is the County administration not allocating additional resources to the County Attorney's Office in order to hire an additional legal staff in order to alleviate the current work load?

Hon. Speaker I think this is not a matter of going around Samburu County to bring an answer to this House, but rather a matter of the concerned to sit down and bring to us the response as simple as that. Hon. Speaker, but it seems like we are taken just for granted, the Department and the concerned are not respecting this House.

Hon. Speaker, just do the reminder but let the concerned Committee call upon the Office and let them appear before the Committee to shade light on the same and if not so, let them summon the Department or the Office and if they are not serious to do so, then we form an *Ad Hoc* Committee to this, just as simple as it is.

Hon. Speaker I do not know what is wrong, we are taken round and round, this is very shameful and bad, let me see sit down.

**MCA Lodokejek Ward,** (Hon. Lekuchula David): Thank you Hon. Speaker, before I proceed to comment about the statement; let me take this opportunity to welcome these beautiful girls from Kisima Girls High School. I think Kisima Girls is the only national girls' high school in Samburu County. Now I stand proud as the member for Lodokejek Ward because the only national girls' school is in my ward. Hon. Speaker, I would like to welcome them again to this honorable house. Hon. Speaker, concerning the statement Hon. Silapia requested, I want to support my Chair. I am also a member of the labor committee. Once an honorable member requests a statement, the committee will write to the relevant department in the executive so that they can provide whatever information that was requested.

Specially Elected MCA, (Hon. Lenamatiyo Silapia): Point of information, Hon. Speaker.

The Speaker, (Hon. Lenamarle Stephen): Point of information from Hon. Silapia.

**Specially Elected MCA,** (Hon. Lenamatiyo Silapia): Thank you Hon. Speaker. I just want the honorable member from Lodokejek to know that this morning, the Hon. Stacy Nareyo indicated that statement requested will brought to this house at 2:30pm, then I was expecting to see that response. The Speaker ruled that I would have the response before 2:30pm and I still do not have it. Hon. Lekuchula was not here in the morning when the matter was being discussed and that is why it is such a burning issue for me.

**MCA, Lodokejek Ward,** (Hon. Lekuchula David): Thank you, Hon. Speaker. I think the honorable member should understand that we do not come from the executive department. Even if we say that we will bring the statement say maybe in the afternoon, what if they have not responded? What do we do? Do you expect us to go and bring them here? Hon. Speaker, protect me. I see Hon. Silapia is about to rise again.

Hon. Speaker, I think this committee needs a bit of time for us to get the relevant answers for the statement. Thank you, Hon. Speaker.

**MCA Loosuk Ward,** (Hon. Lenamparasio Caunda): Thank you Hon. Speaker. Before I contribute, I welcome these Kisima Girls' students to this assembly. These are our children. Their teachers are our brothers. So, welcome so much. I am amused by Kisima Girls. Maybe in future Hon. Lekuchula should build an assembly in his ward because Kisima Girls have visited the chambers several times. Maybe this shows that most of them will become politicians when they finish their school. So, welcome so much, relax and feel at home.

Hon. Speaker, there are two things that have caught my attention here concerning this statement. The first one is that we have so many statements that sometimes even do not have committees to

MCA Suguta Marmar Ward, (Hon. Leleruk James): Point of order.

**MCA Suguta Marmar Ward,** (Hon. Leleruk James): Mr. Speaker, the Honorable Member says there is no department that is concerned with this statement. I happen to be the leader of minority which represents the government and also the Chair, committee on labor. So, the statement is squarely under my docket. Thank you, Mr. Speaker.

**MCA Loosuk Ward,** (Hon. Lenamparasio Caunda): Thank you, Mr. Speaker. I have just heard the second question from Hon. Silapia. She was asking why we only have one legal officer in that office. I do not think it is the honorable minority leader who allocates funds to departments. That is why I am saying personally I am a bit confused. So, Hon. Speaker we should where this department falls under.

Specially Elected MCA, (Hon. Lenamatiyo Silapia): Point of information, Mr. Speaker.

The Speaker, (Hon. Lenamarle Stephen): Point of information from Hon. Silapia.

**Specially Elected MCA,** (Hon. Lenamatiyo Silapia): Thank you Mr. Speaker, I just want the Hon. Member to know that we have the Committee on Labor, Social Welfare, Justice and Legal Affairs; that is the Committee that we directed this Statement to and that is where the office of the Attorney falls. I will read the functions of the same Committee that "All matters relating to the County Public Service, County Civic Education, coordinating participation in Governance at the local level and assisting communities to develop administration capacity procured procedures for the effective Governance, so that is why we say and our Standing Orders indicate that this is where this matter falls, thank you Mr. Speaker.

**MCA Loosuk Ward,** (Hon. Lenamparasio Caunda): Thank you Mr. Speaker, I am now enlightened. Let me go to my second issue; I think that if a Statement is directed to any Chairperson we should all understand as the Hon. Minority or Hon. Lekuchula has said that the

I do not think it is good for us to be quarrelling here among ourselves yet we know the responses are done from the Executive side and not our side. After a reminder we may even summon and follow the procedure, thank you Mr. Speaker.

**MCA Ang'ata Nanyokie Ward,** (Hon. Leshimpiro Paul): Thank you Mr. Speaker. I welcome the students from Kisima Girls High School to our Assembly, feel at home and we are proud of you and look forward to future leaders, politicians and speakers. I am of the same opinion with Hon. Lenamparasio that this Statement ought not to have been directed to the Labor Committee and I have some reasons for that. We are trying to say that Attorney is the only person in the office and we are asking her why she is alone and why she is not being allocated more funds; the question would be from where is it, I am very sure that Attorney still requires more employees with her and more employees.

The problem is that she cannot allocate to herself, then we are somehow crucifying the Attorney trying to question her why she does not have more money; I think this Statement should have been directed to either County Secretary or to the Finance Department. It should not have been because it is like you have a circumciser and you are asking him why have you not circumcised yourself. I am sorry if that is a bad example.

**The Speaker,** (Mr. Lenamarle Stephen): That is a very bad example Honorable, a very big one and I think men will want you to withdraw. Hon. Members let us just...Hon. Lekuchula.

**MCA Lodokejek Ward,** (Hon. Lekuchula David): Mr. Speaker I think the Hon. Member is trying to mislead the public that the Statement was not supposed to be directed to the Labor Committee whereas we have the Committee itself in our Standing Orders and it is in number 10 in the Sectoral Committees of this House and so the Member was not right to say that because it is a full Committee and effective. Hon. Speaker how do you...

MCA Ang'ata Nanyokie Ward, (Hon. Leshimpiro Paul): Thank you Mr. Speaker. I am not refusing that the Attorney's office...

**MCA Loosuk Ward,** (Hon. Lenamparasio Caunda): Thank you Mr. Speaker. I support Hon. Leshimpiro. As much as we are not disagreeing that the Statement was not to be addressed to the Committee but the questions asked are not supposed to be addressed to that Committee, thank you Mr. Speaker.

**MCA Ang'ata Nanyokie Ward,** (Hon. Leshimpiro Paul): Thank you Mr. Speaker. That is exactly what I was supposed to say. The office of the Attorney is in the Labor Committee, there is no question about that but how can you then ask yourselves why have you not been allocated more money am curious to know the type of answer you are going to give us because somebody else has to determine the amount of money that goes to that office. It cannot be the Attorney that is for a fact, there are two things that a member to know if in the event they do not know;

1) That when money is allocated CRA determines two ceilings the ceiling of county assembly and the ceiling of executive the rest of other departments is played around or by the finance department. So it is the department of finance that had to be directed this question

2) so that they tell us why they have not allocated more funds to that office of the attorney for them to employ more people and for them to provide sufficient services to the County that is what we are in disagreement with the members and I don't think that was an error that was done

Leleruk James): thank you Mr. Speaker I raise to say that the issue being asked here is not about budget and the reason why the member was asking for the office not considered, this office was already budgeted and it has money so it is the members to come and interrogate...

Leshimpiro Paul): I just wonder why the member is saying that it is not about money the question number 2 is asking why the County Administration is not allocating additional resources to the county attorney office. **MCA Suguta Marmar Ward,** (Hon. Leleruk James): Mr. Speaker I just want you to protect me because I have said it and we must follow the laws. It is not that am denying the attorney has refused to give out the statements or her office but we have there are procedures and rules of this House.

The action remain that we send a reminder, so after a reminder and then the members will give another priority because what I know as the chairman I know the office is well budgeted and it needs to be accounted for and we are ready to give any statements when being given. It is not upon the chair of the committee to go and debate the executive to give the statements it is the property of the House to deliberate what am just asking is the reminder to send a reminder by next week I give the statements thank you.

**The Speaker,** (Mr. Lenamarle Stephen): thank you Honorable Leleruk the report am getting is that we will... (*order, order*) the report am getting is that this statement was directed to the County Secretary not the Attorney but the question is about the Attorneys office but also directed

**MCA El'barta Ward,** (Hon. Leitoro Jeremiah): Thank you Honorable Speaker, I want to take this opportunity to welcome our students from Kisima Girls and Honorable speaker pertaining to statement 009/2023 as you read the statement I think that is not that right statement that I have requested honorable Speaker.

So I request the Honorable chair from the department of Water and Environment and Natural Resources to actually pick the right question that I asked on 8<sup>th</sup> august 2023.

Honorable Speaker with your permission I would like to read as follows the question was whether the department is aware that Nteremuka borehole in Nteremuka village and Lentabas borehole and Longirgir borehole in Ngilai Elbarta ward are no longer functioning? That was the first question.

**MCA Loosuk Ward,** (Hon. Lenamparasio Caunda): Thank you Hon. Speaker, I sit in the committee of water, so thank you so much Hon. Jeremiah Leitoro. I think we pick from the questions asked by the Hon. Member, they are very pertinent, so we will have to pick the questions and then may be probably on 18<sup>th</sup> as stated by the Hon. Member, he so complaining because of his people, the people who elected him, that place is so dry, you cannot get water easily there and that borehole being not functioning, it will bring a very big problem to them. So Hon. Member jut bear with us on 18<sup>th</sup> we will have to make a response on that. Thank you Hon. Speaker.
