Temporary Speaker, (Hon. Lemoosa Jonathan): Hon. Members, we have a petition and I so wish to read the content of the petition.

LACK OF TEACHERS AND FURNUTRE AT MARTI EARLY CHILDHOOD DEVELOPMENT EDUCATION CENTER AND WAMBA WEST WARD

Hon. Members, in accordance to Standing Order No. 210 (2) (a) I hereby report that a petition has been submitted to the County Assembly of Samburu through the Office of the Clerk by the representatives of Marti village, Lodung'okwe Location, Lpusi Sub-Location, Wamba West Ward, Samburu East Sub-County in Samburu County; concerning children not going to school due to lack of teachers and furniture.

Article 37 of the Constitution of Kenya gives rights to every person to petition public authorities under section 1 (b) of the County Government Act, 2012 gives a person a right to petition County Assembly to consider any matter within its jurisdiction including enacting, amending or repelling any of its legislations, Section 88 of the County Government Act, 2012 also gives citizens right to petition and challenge County Government on any matter under the responsibility of the County Government.

Hon. Members, the salient issue raised in the petition are as follows:

THAT, the ECD center was constructed in 2013 and the County Government has never deployed a teacher in the institution.

THAT, since January 2019, over 50 children who attended Marti ECD center have not been going to school since there was no teacher and furniture.

THAT, the absence of teacher and furniture not only violates the Constitution and other laws, but also denies the children right to quality education.

The petition has therefore prayed **THAT**, the County Assembly of Samburu to intervene in this matter with the view to do the following:

- The County Government to deploy at least one professional and qualified ECD teacher to the school by 8th January, 2024 when the schools will be opening to ensure all those children go to school.
- 2. Supply fifty (50) seats of child appropriate furniture to the school.
- 3. Provide the children in the school with meals.

Hon. Members, pursuant to Standing Order No.211, I will allow limited comments, observations or clarification in relation to the petition.

Hon. Members, I now open the floor for ventilation, thank you. Hon. Phelix Lenamparasio.

MCA Loosuk Ward, (Hon. Lenamparasio Caunda): Thank you Hon. Speaker. It is so unfortunate that the community out there can just sit down and write a petition concerning the learning kids, especially the ECD. As we know, the County Government is in-charge of the ECDs and that is why we have the Department of Education and Vocational Training and Mr. Speaker, I am yet to understand if that ECD previously had a teacher or maybe they need a teacher now; but the biggest thing that we have been seeing in our Wards is that the County Government employed ECD teachers and they are just out there, nobody is supervising them, nobody is in-charge of those teachers and it so unfortunate that I think most, even half of the ECD learning centers in Samburu County have no teachers. Some have employed teachers drawing salaries from the exchequer but are not teaching the kids.

For example, in my Ward I think tomorrow I will be having a meeting because I think the other day a whole village came to my home claiming that for three consecutive years no kid proceeded to class one and this school had an ECD teacher employed by and drawing salary from the County Government and this teacher has never stepped to that ECD center for the last three years even for a single day. Mr. Speaker that is something we should take extremely very seriously; we should be serious on this as this House to see on how we can reclaim the ECDs so that it can come to glory.

If there is a Department that is failing in this County is the Department of Education

And you know all the basics that our kids learn is in the ECD and translates to what the kids become when they grow up and proceed to the primary school, secondary and universities and if these ECDs are not taken care of we will end up producing kids that are not learned you know. Education starts from ECD and we should take these Department into account so that all these ECD teachers be supervised and go to their schools and teach so that when they get their salaries, they earn for what they have done.

For those schools that do not have teachers, I think it is their mandate to ensure that whenever they construct and ECD School, they have to avail a teacher to that school. Mr. Speaker I am in support of that one hundred percent.

MCA Ang'ata Nanyokie Ward, (Hon. Leshimpiro Paul): Hon. Speaker thank you for givin me an opportunity to say a word in this. We have been constructing several ECD centers across the County, in every part of our County. The wrong part of it is that there is no recruitment of teachers being done and I think the percentage of teachers being recruited verses the number of children in need of a teacher is too big.

I do not find the rationale of why we continue building ECD centers yet we do not recruit teachers because each need one another; the teacher needs the pupil and need the classes. I know that there are teachers who have been there and some are as old as the County and they were recruited while they were half-baked, they were not fully trained. Now that we have fully trained teachers, some are diploma holders and they do not find job, where do we want those teachers to go to and what is the importance of us having an ECD training center and continue pushing our students to go to that ECD center to become teachers and we do not give them an opportunity and we have plenty of gaps in our ECDS.

Hon. Speaker I wish we take this matter seriously, I at one time tried to suggest even to the Executive that if it is a question of wage bill, if that is the problem, there are critical areas that cannot stay or cannot be used to ascertain the wage bill. One of the areas is the ECD teachers, ECD Centers and even the health. Those areas are critical and they do not need to be used to curtail the employment of those teachers based on that wage bill.

We need to have a different approach. I was suggesting to them that if they have a money problem why do they not all ow us to allocate some money from the Ward Fund so that we can

engage them on contract basis? If they can allow us to do that, then we will not be having such problems. Otherwise we do not have to continue budgeting for classrooms when we do not have a budget for teachers. Thank you, Hon. Speaker.

MCA Poro Ward, (Hon. Leerte Patrick): Asante Mheshimiwa Spika. Asante kwa kunipa nafasi niweze kusema kitu. Kama walivyosema wenzangu, kuna shida kwa ECD. Sjuiu kama executive wanaona ama ni kupuuza wanapuuza kwa sababu kuna wodi kama Poro amabapo kuna walimu wamestaafu, wengine wamefariki na hadi wa leo hakuna waliopewa nafasi zao. Wengine wamejihamisha bila barua. Ukifuatilia kwenye idara ya elimu, hawa walimu wanakaa kama ng'ombe wasiokuwa na mchungaj. Wanafanya vile wanavyotaka.

Bwana Spika sisi kama bunge tunafaa kutilia jambo hili maanani kwasababu ni maisha ya watoto wetu. Ikiwa hatutaanzakwa mzingi mzuri ktuoka ECD, watoto hawa wakiwa wakubwa hawatakuwa na mzingi mzuri. Tuwajibike kama waheshimiwa tutiliemkazo na ECD iwe na mikakati ya kusaidia. Kwa hivyo naunga mkono.

MCA Wamba West Ward, (Hon. Lemartile Francis): Thank you, Hon. Speaker. The school that was mentioned is in my Ward and I confirm I know the place. It is a very remote area. There is no other government institution or facility in that area. It is so unfortunate that the school was constructed in 2018. Public money has been utilized but the community has not achieved the intended purposes.

When the education committee went around to confirm the school feeding program, it was one of the schools with questions. The report from the department said there was no distribution of food to that center but when the committee came back, the school was in the list and being allocated food. That is why on that day I raised a query on which report we will go by because the two reports differ. The committee and departmental reports differ. So Mr. Speaker, because I know the area, when that report came I made an effort to visit that ECD Center and I found it to have been occupied by a certain family.

It is no longer a public utility. Personally I did not know it was constructed by the County Government. I thought it was the family that assisted the village by donating one room for the students to learn in. it is so unfortunate that we construct schools and we do not follow up to

make them institutions to assist the community. This is not the only school that has been occupied by families, there are several of them in our County.

The department cannot ascertain whether the school exists or not. As my colleague said, if the money allocated to the department is not enough we can increase the amount so that they can employ more teachers to suit those schools. I beg you give us direction for the committee to go and confirm that and bring us a concrete report and follow up with the department to find out when the school was started and what went wrong around that period.

Specially Elected MCA, (Hon. Lenamatiyo Silapia): I also rise to raise my sentiments on the same matter. The community has seen the importance of education at the grassroots level. I know you understand that education is one of the devolved functions on the side of ECD Centers. Hon. Speaker, we see that we have so many challenges. That is why the community sat down and brought petitions to this honorable house so that their prayers will be heard.

I request this honorable house and the concerned committee to take the matter seriously. I think Marti ECD school is one the schools that raised so many complaints because according to the department's report, they normally get allocations. When the committee visited the school, there were no learners. Nothing was there. The community saw that it is good to petition this house so that their prayers can be heard.

This is an issue that is being raised all over the County. The other day I was in Wamba North Ward, Ngilali location. I saw a school whose building is almost collapsing and children are learning in it. In 2021 I raised the same issue. Up to date the department has made no effort to ensure that those children learn in a safe and conducive environment. Hon. Speaker, those children are now learning in trees beside a building that was constructed by the County Government in 2019.

Now it is just a white elephant, standing there and nobody is using it. Marti ECD school is standing there and is not in use because there is no teacher. We see so many issues arising from the department of education. It is my prayer to this house and the committee to seriously look into this matter. The other day I brought up the matter of one of the ghost schools that the department is saying they receive food and the committee confirmed that they are not getting anything because there are no learners there. It is just a building.

Member confirmed here that it just a personal House or whatever. My request Hon. Speaker is that the prayer of that community to be heard and the Committee also to follow up so that we can get a teacher who can perform their duties and also the community to own that project as their project. The community saw that this is a school with no teacher. It is my prayer and request to the Hon. Members that we look to this matter in seriousness because when you read the mood of the Members this issue is experienced everywhere, thank you Hon. Speaker.

Temporary Speaker, (Hon. Lemoosa Jonathan): Thank you the Hon. Silapia. Hon. Lealmusia Ali.

MCA Ndoto Ward, (Hon. Lelamusia Ali): Thank you Mr. Speaker Sir. I also raise to concur with this community that has brought this Petition to this Hon. House. It is very clear from my colleagues who spoke before me that we have a very serious problem as far as ECD is concerned; in my Ward I have some 62 ECD centers and only 25 teachers that is less than a half. So, you really wonder how about the 50 plus percent of these schools.

This has even become a teething problem to the community because we have constructed ECD classes and we have no teachers. The community is forced to go deep into their pockets and get somebody who is not even well trained to assist these kids. This shows how our people down there really value Education because if they can volunteer their resources it is apparent that they really need this service.

As far as the ECD Department is concerned it is the most affected. We have officers in charge of these nurseries in all the Wards and they give their monthly reports which makes me wonder why the Executive is not doing anything. I thought Education should even call Leaders, we sit down and agree on how to manage this because it is becoming an embarrassment.

I think they are only active when they are adding up their numbers because of the ration they provide to these centers so that they can benefit which is very wrong. We must have a way of handling this issue. Even the other day you realized that we had some replacements which did not take off because of the misunderstanding between the Board and the Education Department which is very embarrassing. Up to now this has not been solved and you realize that the other day the advertised some 22 vacancies and we had over 400 applicants and so you can imagine this.

If we have people who are out there who did this ECD education and they are out there looking for these jobs and we have several ECD Centers which do not have teachers, what is the point for us to be Budgeting to that Department. I suggest to this Hon. House that we should deal with this Education Department honestly, we deal with them and ensure they do not supply that kind of...because it is better for us to have enough teachers that even having food that is being sold in this town for the purposes of this kids or fake ECD Centers to justify their expenditure.

I would really suggest that we must do something as an Honorable House and we must save our children to ensure that they have good Education. We want our primary schools to have kids from these centers because that is where we have a bigger enrolment who go through this ECD classes. I really thank this community for Petitioning to this House and we must do something, thank you Mr. Speaker Sir.

Temporary Speaker, (Hon. Lemoosa Jonathan): Thank you Hon. Lealmusia Ali. We had ventilation on this and I want to agree with the Hon. Members that we have challenges on this service knowing very well that it is a co-function of the County Government and it is a devolved function. We got some information like what the Hon. Paul Leshimpiro is saying that whether we have Financial challenges but of course we can have an alternative. We can use a bit of the Ward Fund to have a few volunteers here and there as they await full time employment.

We also have Quality Assurance Officers (QUASO) being an issue and maybe they are not really up to their task, this is what the Members have said. It is true that it is an issue that affects each and every Ward on issues or matters, furniture matters, teacher's shortage, matters quality and such. Therefore Hon. Members. Pursuant to Standing Orders 22/12/1, the Petition should be committed to the relevant Committee for its consideration in this case and I therefore direct that the same be committed to the Sectoral Committee on Education and Vocational Training in terms of Standing Order number 212/2, the Committee is required in not less than 60 Calendar days from the time of reading this Paper which is today the 6th December 2023 to respond to the Petitioner by way of report, address to the Petitioner and lay on this table of the County Assembly the same report. Hon. Members I sincerely thank you.

PRELIMINARIES

Par tI preliminaries which is part is clause 2; interpretation in this act unless the context otherwise requires county means County government of Samburu authorized itinerary means making payment through an officer appointed by the county to collect revenue or through any other mode of payment as may be prescribed by the County. CESS means fees charged for goods specified

A person applying for license under sub-section 2 shall be charged a fee specified in the second schedule depending on the location the size of the business

A person who contravene any of the provisions of this section commits an offence

Fees- A person who carries out an activity listed in the third schedule shall be charged a fee at a rate therein there is CESS and FEES on markets there is the charges and the fees for that and other fees and other fees again. Part 4; payments (clause 13th)

Clause 13th reads, any payments to the county shall be paid through an authorized tender. An officer appointed to the County to collect revenue should have an identification card issued by the County officials.

County official receipts shall be issued for all payments made to the County. The person shall not receive or collects any money on behave of the County unless he has been appointed to do so or has authority as the receiver and collector of the County revenue. A person who contravenes the provision of this section commits an offense.
