Honorable Speaker,

Pursuant to Standing Order 41(2) (c) I hereby request for a statement from the Chairperson Sectorial Committee on Tourism Trade and Co-operative Development on specific projects and functions of the Samburu County Baragoi Conservation unit in Samburu North Sub-County.

Honorable Speaker,

Nachola is experiencing high human/wildlife conflict. It is now over three years since the creation of conservancies in Baragoi, there is no impact seen in their area of conservation. Many animals are unprotected especially in Nachola area.

Honorable Speaker,

In light of the above, the Chairperson should inquire into and report on:

- a) What are the functions given by the county to the conservancies?
- b) How is the working relationship between the Baragoi conservation units and Samburu North Sub-County administration in terms of administration supervision?
- c) What is the progress of Baragoi Conservancy unit so far in terms of conservation in Nachola ward?
- d) How much budget is allocated to Baragoi Conservancy Unit and how are they ensuring that there are tangible results?
