Special Elected MCA, (hon. Linda Naserian): Thank you Mr. Speaker. Early this month, the Committee on Delegated County Legislation tabled a report in regard to the said policy and each member was served with a copy. One of the recommendations of the committee is that the House approves the establishment of the County Liaison Office in Nairobi by the County Public Service Board which will enable the county to streamline the performance of devolved functions at the county level through proper coordination and consultations with the national government and other stakeholders in the devolution.

The committee went through the policy and we came into terms that it was in order with the relevant laws that guides the operations of this hon. House and the committee came up with the report which has led to the formulation of this motion that urges the hon. Members to agree with the committee that the policy is in order and is in the interest of the people that we serve.

I, therefore, urge the hon. Members to support the motion so that it can allow a smooth flow of activities in our county. Thank you.

MCA Maralal ward, (hon. Elly Loldepe): Thank you Mr. Speaker. I stand to support the motion as moved by hon. Linda. But I wish to ask her for a clarification. In page 3 after annex on what the committee found, part (g) in particular, that the policy will not involve expenditure from the County Revenue Fund appropriated through the PFM act, 2012 and approved through this regulation. I don't know whether that statement is relevant within the context of this policy in this particular case. I know the policy is long overdue and it should be supported but I don't know the relevance of that statement.

I want to put some clarification. If you go back to the annexes on this, you will still find an annex showing the staff. This means, in my view, that there are budgetary implications because after the County Secretary, there is County Liaison Officer, the Administrator, the Secretary and the support staff.
