## **Procedural Motion-The Samburu County Appropriation Bill, 2020, Second Reading.**

**MCA Elbarta Ward**, (Hon. Peter Lempei): Thank you Hon Speaker. Hon. Speaker, I beg to move the following motion, **THAT** the Samburu County Appropriation Bill 2020 now be read for the second time. Thank you Hon. Speaker. And I request the Hon. Dube to second the motion.

**The Samburu County Appropriation Bill, 2020, Third Reading. Committee of the Whole House.**

**Chairperson of the Committee of the Whole House,** (Hon. Adamson Lanyasunya): Order order order Hon. Members, may I take this opportunity to welcome you to the Committee of the Whole House to deliberate and approve the Samburu County Appropriation Bill 2020. I now call the clerk to read the clauses.

*Clause 2: The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the services of the year ending on the 30<sup>th</sup> June, 2020, the sum of Kenya Shillings five billion, one hundred and eight million, six hundred and one thousand three hundred and ninety one only, and that sum shall be deemed to have been to have been appropriated as from the 1<sup>st</sup> July, 2020 for the services and purposes specified in the schedule.*

**Chairperson of the Committee of the Whole House,** (Hon. Adamson Lanyasunya): Order Hon. Members, we have a very long Bill to discuss. *(The Chairperson consults with the clerk)* I now propose the question on clause 2 that the County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the services of the year ending on the 30<sup>th</sup> June, 2020, the sum of Kenya Shillings five billion, one hundred and eight million, six hundred and one thousand three hundred and ninety one only, and that sum shall be deemed to have been to have been appropriated as from the 1<sup>st</sup> July, 2020 for the services and purposes specified in this schedule.

**Chairperson Committee of Whole House**, (Hon. Adamson Lanyasunya): Hon. Chairperson for the Committee on Budget and Appropriation.

I beg to move that the Committee do report to the Assembly it's consideration of the Samburu County Appropriation Bill 2020 and its approval thereof without amendments.

**MCA Waso Ward**, (hon. Paul Wonyan'g): I seek your indulgence to check on the arithmetic's of the Budget because for me I am seeing like we have 66 million on the recurrent, it is minus 66 million. If we can check on that I will be obliged.

**MCA Elbart Ward**, (hon. Peter Lempei): I think we ought to stick to the text of the law, as far as we are concerned we cannot have the debate opened to discuss on the provisions of that Bill because the Bill is there. When the question will be put it is either the Member rejects it or supports it. It is not procedural and not provided for in our Standing Orders.

**MCA Waso Ward**, (hon. Paul Wonyan'g): It is not that I am rejecting it, I am just checking on the arithmetic's. If you total R4211 until R4221, it does not give us the sub total of 3, 447, 144, 186.

**MCA Elbart Ward**, (hon. Peter Lempei): The text of law states that once we passed that unanimously we cannot revert back. Let us stick to the law.

**Chairperson Committee of Whole House**, (Hon. Adamson Lanyasunya): Since we had already passed that then it is the matter of additions then it can be rectified.

**MCA Elbart Ward**, (hon. Peter Lempei): If indeed there are the clerical issues that have come up then that is more of an executive function, we can look at the errors and communicate it later through the clerk.

**Chairperson Committee of Whole House**, (Hon. Adamson Lanyasunya): When I look at the report that we had adopted it amounts to the same figure in the Bill.

**MCA Elbart Ward**, (hon. Peter Lempei): Much obliged. That is the provision.

**Chairperson Committee of Whole House**, (Hon. Adamson Lanyasunya): Thank you hon. Wonyan’g for sighting that. I now propose the question that the Committee do report to the House it’s consideration of the Samburu County Appropriation Bill 2020 and its approval thereof without amendments. I now put the question that the House do report its consideration of the Samburu County Appropriation Bill 2020 and its approval thereof without amendments.

**The Speaker**, (Mr. Solomon Lempere): Mr. Wonyan’g give a response on whether you are dressed appropriately.

**MCA Waso Ward**, (hon. Paul Wonyan’g): I have some pain in my neck and I ask that you pardon me for today. I also think that the Chair of Budget is targeting me because I did my arithmetic’s on the recurrent Budget and I realized that there was a shortfall, in fact in the 3, 447, 144, 186 there is a shortfall of 66 million when we had the sub totals under the recurrent.

**MCA Elbarta Ward**, (hon. Peter Lempei): That Motion was moved and it was owned by the majority. The hon. Member cannot take us back. We had our way and he had his say.

**The Speaker**, (Mr. Solomon Lempere): I have pardoned you hon. Wonyan’g and next time ensure that you wear a tie.
