MCA Lodokejek Ward, (Hon. Jerias Leshoomo): Thank you Hon. Speaker, pursuant to Standing Order number 47/1, I wish to move a motion that this House debates and approves the report of the Committee of Finance, Economic Planning and Marketing on the public participation report of the Samburu Finance bill, 2015 tabled on 30th September, 2015. The Deputy Speaker, (Hon. Adamson Lanyasunya): Hon. Members I now propose the question on the motion as moved by Hon. Leshoomo. Pursuant to Standing Order 47/1, I wish to move a motion that this House debates and approves the report of the Committee on Finance Economic Planning and Marketing on the public participation report on the Samburu Finance bill, 2015 tabled on 30th September 2015, Hon. MCA Lodokejek Ward, (Hon. Jerias Leshoomo): Thank you Hon. Speaker. I am pleased to present and table the report of the County Assembly by the Committee on Finance, Economic Planning and Marketing regarding the Finance bill, 2015 on public participation. The Committee of Finance, Economic, Planning and Urban Development was established by the County Assembly and has the following seven members as indicated in the report. The roles of the sectorial committee as stated in the Standing Orders of the County Assembly shall be to investigate, inquire into all matters relating to the mandate in the management and activities of the special operations related to the assigned department. The committee also thanks the Speaker and the Clerk of the County Assembly of Samburu for the support in the conduct of the public hearing. It is my pleasant duty pursuant to Standing Order number 123 to present a report of the Committee on Finance, Economic Planning and Marketing for considerations by the House. We all know that the Samburu Finance bill was brought about in line with the budget but it was passed for the financial year 2015/2016, article 218 of the interim Standing Order 218/1, the consideration of the finance bill. Following the submission of the legislative proposal by the Member of the County Assembly responsible for the Committee on Finance under the Standing Order 213 pronouncement of budget highlight and (*inaudible*) preventive measures. The finance Committee shall introduce to the County Assembly the Finance bill in the form which the bill was submitted as proposed by the Member of the County Executive Committee responsible for finance together with the report of the committee on the bill. The main objective of the bill is really to impose fees and other charges on further services provided by the County. We all know that the budget revenue that we were supposed to collect for the County was really to supplement the budget and the money that we were given by the National Government. I think that it is prudent for us to adopt the report so that it enables this County to collect revenue as stated in the Finance bill, thank you Mr. Speaker.
