PRAYER

PROCEDURAL MOTION

The Limitation of Debate on Bills Sponsored by Parties or Committees

The Deputy Majority Leader, (Hon. Elizabeth Kalapata): Thank you Hon. Speaker, I beg to move the following Motion;

THAT, notwithstanding the provisions of Standing Order 93 (4), this House orders that each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of Minority Party be limited as follows:

A maximum of forty-five minutes for the Mover in moving and fifteen in replying.

A maximum of thirty minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee) and a maximum of ten minutes for any other Member speaking except the Leader of the Majority Party and the Leader of Minority Party who shall be limited to a maximum of fifteen minutes each (if the Bill is not sponsored by either of them); and the priority in speaking be accorded to the Leader of Majority, the Leader of the Minority and the Chairperson of the relevant Departmental Committee, in that order.

I call upon Hon. Zamzam to second.

(Hon. Zamzam Ismail bows to second the Motion)

The Deputy Speaker, (Hon. Jonathan Lemoosa): Very well Deputy Majority Leader. Hon. Members I now propose the Question;

THAT, notwithstanding the provisions of Standing Order 93 (4), this House orders that each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of Minority Party be limited as follows:

A maximum of forty-five (45) minutes for the Mover in moving and fifteen (15) in replying.

A maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee) and a maximum of ten (10) minutes for any other Member speaking except the Leader of the Majority Party and the Leader of Minority Party who shall be limited to a maximum of fifteen minutes (15) each (if the Bill is not sponsored by either of them); and the priority in speaking be accorded to the Leader of Majority, the Leader of the Minority and the Chairperson of the relevant Departmental Committee, in that order.

(Question Put and Motion passed)

PROCEDURAL MOTION

Limitation of Debate On Individual Members' Bill

The Deputy Majority Leader, (Hon. Elizabeth Kalapata): Thank you Hon. Speaker I beg to move the following Motion.

THAT, notwithstanding the provisions of Standing Order 98 (4), this House orders that each speech in a debate on Bills not sponsored by a Committee, the Leader of Majority Party or the Leader of Minority Party be limited as follows:

A maximum of three hours and thirty minutes for the Mover in moving and ten minutes in replying, a maximum of thirty minutes for the Chairperson of the relevant Committee and a maximum of ten minutes for any Member speaking except the Leader of Majority Party and the Leader of Minority Party who shall be limited to a maximum of fifteen minutes each and that priority in speaking be accorded to the Leader of Majority Party, the Leader of Minority Party and the Chairperson of the relevant Committee in that order.

I call upon Hon. Leshoomo to second the Motion.

The Deputy Speaker, (Hon. Jonathan Lemoosa): Very well Majority Leader. Hon. Members I now propose the Question **THAT**, notwithstanding the provisions of Standing Order 98 (4), this

House orders that each speech in a debate on Bills not sponsored by a Committee, the Leader of Majority Party or the Leader of Minority Party be limited as follows:

A maximum of three hours and thirty minutes for the Mover in moving and ten minutes in replying, a maximum of thirty minutes for the Chairperson of the relevant Committee and a maximum of ten minutes for any Member speaking except the Leader of Majority Party and the Leader of Minority Party who shall be limited to a maximum of fifteen minutes each and that priority in speaking be accorded to the Leader of Majority Party, the Leader of Minority Party and the Chairperson of the relevant Committee in that order.

Members, I now put the question which is **THAT**, notwithstanding the provisions of Standing Order 98(4), this House orders that, each speech in a debate on Bills not sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of three hours and thirty minutes, with not more than 30 minutes for the Mover, in moving and 10 minutes in replying, a maximum of 30 minutes for the Chairperson of the relevant Committee and a maximum of ten 10 minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes each; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.

The Deputy Leader of Majority, (Hon. Elizabeth Kalapata): Thank you Hon. Speaker Sir. Hon. Speaker, I beg to move the following Motion; Limitation of Debate on Motions **THAT**, notwithstanding the provisions of Standing Order 98(4), this House orders that, each speech in a debate on any Motion, including a Special Motion be limited in the following manner:- A maximum of three hours with not more than 20 minutes for the Mover and 10 minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of 15 minutes each, and that 10 minutes before the

expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order. Thank you Hon. Speaker Sir. I call upon Hon. Stephanie Lanyasunya to second the Motion.

The Deputy Speaker, (Hon. Jonathan Lemooosa): Very well Majority Leader. Hon. Members, I now propose THAT, notwithstanding the provisions of Standing Order 98(4), this House orders that, each speech in a debate on any Motion, including a Special motion be limited in the following manner:- A maximum of three hours with not more than 20 minutes for the Mover and 10 minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of 15 minutes each, and that 10 minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.

Speaker, I beg to move the following Motion; Limitation of Debate on Reports of Committees, THAT, notwithstanding the provisions of Standing Order 98(4), this House orders that, each speech in debate on Reports of Committees, or any other Report submitted to the House for which limitation of time has not been specified, be limited as follows:- A maximum of 60 minutes for the Mover in moving and 30 minutes in replying, and a maximum of 10 minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of 15 minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order. I call upon Hon. Josephine Lesilampa to second the Motion.

The Deputy Speaker, (Hon. Jonathan Lemooosa): Very well Majority Leader. Hon. Members, I now propose the Procedural Motion; Limitation of Debate on Reports of Committees as read by the Deputy Majority Leader.

Hon. Members, I now put the question which is THAT, notwithstanding the provisions of Standing Order 98(4), this House orders that, each speech in debate on Reports of Committees, or any other Report submitted to the House for which limitation of time has not been specified, be limited as follows:- A maximum of 60 minutes for the Mover in moving and 30 minutes in replying, and a maximum of 10 minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of 15 minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order.

(And the procedural Motion - Limitation of Debate on Reports of Committees was passed)

PROCEDURAL MOTION

The Deputy Leader of Majority, (Hon. Elizabeth Kalapata): Thank you Hon. Speaker Sir. Hon. Speaker, I beg to move the following Motion; Limitation of Debate on Motions on the Address

by The Governor, **THAT**, notwithstanding the provisions of Standing Order 98(4) and in furtherance to the provisions of Standing Order 24, this House orders that, debate on the Motion on the address by the governor be limited to no more than 30 minutes for the mover in moving and replying. 20 minutes for the Leader of Majority Party and five minutes for any other member speaking. I call upon Hon. Zamzam to second the Motion.
