### STATEMENTS

#### **IMPLEMENTATION STATUS OF PROJECTS FROM THE YEAR 2016/2017**

**MCA Lodokejek Ward,** (hon. Jerias Leshoomo): Hon. Speaker, pursuant to Standing Order 45(2) (c), I hereby request for a statement from the Leader of Majority regarding the projects implementation status report for FY 2016/2017.

In accordance with the PFM Act, 2012 section 127, county accounting officers are required to prepare and submit to the County Treasury Annual Cash Flow plans, which forms the basis for subsequent requisition of funds from the County Treasury for budget implementation during the financial year. To prepare the cash flow projection, accounting officers should be guided by the departmental annual work plans and procurement plans.

In addition, the accounting officers are under obligation to implement the budget in accordance with the approval given through the annual appropriations except where amendments are made through the supplementary budget.

As part of the budget implementation, county budget entities or departments are required to prepare cash flow projections based on annual development and procurement plan. The County Treasury compares the projections to inflow of revenues from all sources, including own revenue, transfers from national government, and any other source, and based on expected inflow of all cash receipts. The County Treasury sets monthly cash flow limits.

Hon. Speaker, In view of this, the Chairperson should inquire into and report on;

- i. Project implementation status report for all the departments for the Financial Year 2016/2017
- ii. What is the status of unimplemented but budgeted projects for FY 2016/2017?
- iii. What is the status of incomplete projects for the same period?

The statement comes in line with our budget plans for the last few years. This House passed some plans and budget for implementation by the county government but in our wards there are
