Thank you hon. Speaker, I beg to give Notices of the following Motion that Pursuant to the County Assembly Standing Orders 47/1, aware that the devolved Governments are a key component in the governance of Kenya established under article 11 of the Constitution of Kenya. Further aware that the office of the Member of the County Assembly has been strongly anchored as a fundamental component in the County Government administrative system cognate of the remunerative needs of each state and public officer to ensure adequate facilitation to ensure successful exercise of their duties and mandates.

Further aware of the existence disparities within the state of office within the republic for remuneration of the office holder particularly the payment of House allowance to which the Members of the County Assembly have to their determent been deprived off. Nothing in the High Court in the republic as in Constitutional Petition number 328 of 2016 Council of Governors Verses Salaries and Enumeration Commission provides that denying certain state

officers certain benefits enjoyed by other state officers is discriminatory and unjustifiable selective and contrary to Article 27 of the Constitution accusing that such a conduct is a violation of fundamental right of the state officers which such a conduct is desirous of the desertion by the members of the County Assembly adnexa and where that the Governance Council of the County Assembly Governing Council of the County Assembly forum has resolved that the non-payments of the Housing allowance for the Members of the County Assembly is fundamental beneath the right of the Members.

Whereas the Governing Council has further resolved and directed that there be effective payment of Housing allowance for the Members of the County Assembly in tandem with the High Court findings and whereas the resolutions of the Governing Council findings was considered un relative applicability from the parliament of Kenya payment of House allowance to its Members despite lack of salaries and remuneration commission directive in alternative of the same it is now therefore resolved that this House does approve and adopt the resolution of the County Assemblies Forum governing council that:

- 1) The Members of the County Assembly be paid House allowance in tandem with the ideal and adequate endearment.
- 2) That the payment of the House Allowance be effected and implemented as of the date of issue of the ruling of the High Court in Constitution Petition number 328 of 2016 being the fifth day of October 2018.
- The implementation of the payment of the House allowance to be allowance to the Members of the County Assembly be commenced with immediate effect.
