MCA Lodokejek Ward, (Hon. Jerias Leshoomo): Thank you Hon. Speaker. Pursuant to Standing Order 41(2) (c) I hereby request for a Statement from the Chairperson for Sectoral Committee on Labour, Social Welfare, Justice and Legal Affairs regarding the County Executive's staff audit.

Hon. Speaker Sir, Article 235 of the Constitution of Kenya, 2010 states that a County Government is responsible within a framework of uniform norms and standards prescribed by the Act of Parliament for establishing and abolishing the Public Service, appointing persons to hold those offices or act in those offices and confirming appointments and exercising disciplinary control over and removing persons holding or acting in those offices.

Hon. Speaker, the specific human resource audit functions are to determine the effectiveness of the human resource functions as it relates to the Samburu County compliance with state and federal employment regulations to analyze indicators and rectify any restraining forces that affects the County's ability to operate effectively and to identify any potential compliance issues that allows the County to defend its employment practice and policies challenged by agencies or individuals.

Hon. Speaker, early this year a human resource audit was conducted to review current human resource policies, procedures, documentation and systems to identify need for improvement and enhancement of the human resource functions as well as assess compliance with overcharging rules and regulations.

Hon. Speaker, there are persons employed by the County Government and are yet to be seen in their respective offices hence earning salaries on a monthly basis. One case for instance, Hon. Speaker, is Mary Ekai Kanyaman who was employed as an Advisor to the Governor on gender matters yet she draws a salary as a Director in the ECD section of the Education Department.

In view of this Hon. Speaker, the Chairperson should enquire into and report to this House on; -

- 1. Condition of employment of Mary Ekai Kanyaman
- 2. Qualification of Mary Ekai Kanyaman.
- **3.** Findings of the Human resource audit report
- **4.** Explanation of the legal fees paid to Mary Ekai Kanyaman court cases
 - a) Mary Ekai Kanyaman Vs County Assembly of Samburu the Case is in Nanyuki.
 - b) Mary Ekai Kanyaman Vs County Assembly of Samburu the case is in Nakuru
 - c) Mary Ekai Kanyaman Vs County Assembly of Samburu the case is in Nyahururu
 - d) Mary Ekai Kanyaman Vs the Speaker & the Clerk of County Assembly of Samburu the case is in Nanyuki.
- **5.** Mary Ekai Kanyaman has never reported to work despite the appointment as an Advisor at the Office of the Governor.
