**Leader of Majority,** (Hon. Christopher Lentukunye): Thank Hon. Speaker. Mr. Speaker, I stand to table the County Budget 2020/2021 financial year.

Members, I wish to commit the budget estimates for the financial year 2020/2021 to the Committee on Budget and Appropriation in consultation with other sectoral Committees. The Committee to interrogate the budget and give a report to this House within the stipulated time as provided as per the Standing Orders.
