QUESTIONS AND STATEMENTS

Specially Elected MCA, (Hon. Zamzam Ismael): Thank you Hon. Speaker. Pursuant to Standing Order 43 clause (2 c), I hereby request for a Statement from the Chair, Liaison Committee concerning unexplained delay in response to Statements by the committees in the respective Chairs.

Hon. Speaker, as you know, Statements are opportunities the Assembly exercises the oversight role over the Executive functions. I wish to note and appreciate the zeal to which the Members have leverage Statements to obtain information and answers from the Executive on the crucial issues in the county. This oversight role can only successes if committees and the chairpersons meet half of the bargains which members request Statements. This process will only succeed if responses are given timely and the House approves on the same.

We have also noted with concern unexplained details in responding to Statements by committees. Lack of response from the Executive and poor response of the Statements on the floor. An audit on all Statements from the fourth session up to date that committees and by extension Chairpersons have not given Statements the commitment they deserve. It is unacceptable that the House which waits for Statements for response up to six months yet Chairpersons while in plenary commit to disburse with such Statements in two weeks.

Hon. Speaker, on the fourth session of 2020, we have a total of six pending Statements while in the third session of 2019, we have a total of five pending Statements. So in total, we have 11 pending Statements. Details of the same are attached to the communication.

Therefore, I hereby request response from the Chair of Liaison Committee to give a status report to the Assembly on the pending Statements and inquire into reasons for the delay and lack of timely response by the committee Chairs as well as County Executive Committee Member and the measures to be assured we do not fall under this trap again.
