THAT aware that the County Assembly of Samburu is established by Article 177 of the Constitution and its main role is set out in Article 185 of Constitution.

Noting that since its inception the Assembly has held its sittings in Maralal with its committees occasionally visiting the sub-counties and wards on fact finding missions: Cognizant of the need to enhance the interaction between the Assembly and the people as a means of bringing the Assembly closer them; appreciating the recommendation of the House Business Committee that a Sitting of the Assembly be held away from the traditional premises in Assembly Buildings, Maralal, in order to;

- i. Promote the role and work of the Assembly,
- ii. Highlight existing opportunities for people to get involved in the work of the Assembly; and

I wish we could have started earlier, but since we have started, people are going to benefit from the wisdom that the legislators will be demonstrating. Thank you Madam Speaker

MCA Maralal Ward, (Hon. Fred Kiragu): Thank you Madam Speaker. I rise to support the motion but I have a few comments to make. That, it is good to go and meet the people on the grassroots. And as we move out of Maralal as a town, when the Committee chose Samburu East to be the first sitting outside Assembly buildings, it would have been wise to choose Ngilai where people will never have a chance of seeing any Assembly sittings anywhere. Because Wamba town must have had chances of either going to parliament in Nairobi or coming here like when we had problem with SAWASCO. But in places like Ngilai, they cannot reach Wamba and they cannot reach Maralal.

And then when we decide to go Samburu North, we go to Opiroi, where they might never have a chance of visiting any of the parliaments in the country. But any way it is good to start with Wamba, the difference between Wamba and Maralal is minimal. But then I also wish to say that, as we got out, Maralal ward should be seen that there are people who are not accessible to this House. So we can go to Lakira one time maybe if it is seriously meeting the people. But I support this idea, it good that they see us. Then it is also good to tell the Hon. Members there is danger even of going out. Because others would see and develop appetite for your seat out there (the Hon. Members laugh). They would see the good of being MCA. So I think that also should be taken into account. Thank you Madam Speaker, I support the motion.
