1. The Samburu County Community Conservancies Act, 2019 referred herein to as the Principal Act is amended by deleting the words 'County Community Conservancy Fund Manager' and replacing with the words 'Fund Administrator' on section 13 paragraph 1 (b) and section 19 (i).

2. The Principal Act is amended by adding the words 'and/or Director' immediately after the Officer under section 13 paragraph 1 sub paragraph (c).

3. The Principal Act is amended by deleting paragraph (b) of section 15.

I propose the Question that the amendment of section 13 of the Principal Act be part of the Bill.

I put the Question that the amendment of section 13 of the Principal Act be part of the Bill as read.

*Functions of the fund administrator: The Principal Act is amended by deleting sub-section 2 and 3 of the section 19 and inserting a new section immediately after section 19 (a)*

Insertion of new section 19 (b). 19 (b) the fund administrator shall perform the following functions;

- (a) Shall ensure that the earnings of accruals of the funds are retained in the fund unless the County Executive Committee Member for finance directs otherwise.
- (b) Shall ensure that any money held in the fund including any earnings or accruals referred to in paragraph (a) is spent only for the purposes for which the funds is established.
- (c) Shall prepare accounts for the funds for each financial year.
- (d) Not less than three months after the end of each financial year submit financial statements relating to those accounts to Auditor general and the Public Finance Management Act 2012.
- (e) Present financial statement to the County Assembly.
- (f) Shall ensure that the accounts for the funds and the annual financial statements relating to those accounts comply to the accounting standards prescribed and published by the Accounting Standards Board from time to time.
- (g) Carry out any functions as maybe assigned by the County Executive Committee Member responsible for finance.
- *(h) The administration cost of the funds shall be a maximum of three percent of the approved budgets of the funds.*
- (5) The Principal Act is amended by deleting the word "Board" and replacing it with "Fund Administrator" under the following sections; 24 (a) (1), 25 (1), (2), 26, 28, 29 and 30.
