COMMUNICATION FROM THE CHAIR

Opening of the Fifth Session

The Speaker, (Mr. Lempere Solomon): Hon. Members, I have a communication to make. I take this opportunity to welcome you to the Fifth session of this Second Assembly. Counties are also to assist communities to develop the administrative capacity to enhance their exercise of power and participation in governance at the local level.

In View of this, Hon. Members, We would soon roll out '*Bunge Mashinani*' initiative that would see us hold our proceedings outside Maralal. MESSAGES

Transmission of the BBI (Constitution Amendment Bill, 2020 to County Assemblies

The Speaker, (Mr. Lempere Solomon): Hon. Members, I have a message on Transmission of the BBI (Constitutional Amendment) Bill, 2020 to County Assemblies. Hon. Members, I have the following Message to make pursuant to Standing Order 39(1): - Hon. Members, my Office is in receipt of a letter dated 26th January 2021, from the Chairperson of the Independent Electoral

and Boundaries Commission (IEBC), Transmission of the BBI (Constitutional Amendment) Bill, 2020 To County Assemblies.

The letter reads as follows, which I now reproduce verbatim: -

"The Independent Electoral and Boundaries Commission ("the Commission") received a draft bill to amend the Constitution by Popular Initiative pursuant to Article 257 of the Constitution of Kenya, 2010 dubbed Building Bridges Initiative. The said Initiative was promoted by Hon. Dennis Waweru and Hon. Junet Mohamed.

In compliance with Article 257 (4) of the Constitution of Kenya, 2010, the Commission undertook a verification exercise to ascertain whether the Building Bridges Initiative is supported by at least one million registered voters.

The Commission, through interim verification of data captured as of 19th January 2021, has confirmed and is stated that the Initiative has been supported by 1,140,845 registered voters. This is therefore to notify you that the Initiative has met the requisite threshold as provided in Article 257(4) of the Constitution of Kenya, 2010.

Pursuant to Article 257 (5) the Constitution of Kenya, 2010, the Commission hereby submits a copy of the draft BDI (Constitutional Amendment) Bill 2020, to your County Assembly for consideration within three months from the date hereof. In conformity with Article 257(6) you are required to submit the decision of your County Assembly to the Speakers of the National Assembly and the Senate within three months from the date of this letter."

Now therefore, Honorable Members, I now draw your attention to the provisions of Article 257, which provides as follows regarding the consideration by the County Assembly of Constitutional Amendment Bills by Popular Initiative, which reads thus: -

257. (1) an amendment to this Constitution may be proposed by a popular initiative signed by at least one million registered voters

(2) A popular initiative for an amendment to this Constitution may be in the form of a general suggestion or a formulated draft Bill

(3) A popular initiative is in the form of a general suggestion, the promoters of that popular initiative shall formulate it into a draft Bill.

(4) The promoters of a popular initiative shall deliver the draft Bill and the supporting signatures to the Independent Electoral and Boundaries Commission, which shall certify that the initiative is supported by at least one million registered voters

(5) If the Independent Electoral and Boundaries Commission is satisfied that the initiative meets the requirements of this Article, the Commission shall submit the draft to each county assembly for consideration within three months after the date it was submitted by the Commission.

(6) If a county assembly approves the draft Bill within the months after the date it was submitted by the Commission, the speaker of the county assembly shall deliver a copy of the draft Bill jointly to the Speakers of the two Houses of Parliament, with a certificate that the county assembly has approved it.

(7) If a draft Bill has been approved by a majority of the county assemblies, it shall be introduced in Parliament without delay.

Hon. Members, the IEBC having dispensed with its mandate in so far as this matter is concerned has forwarded The BBI (Constitutional Amendment) Bill, 2020 for the Assembly's consideration

For that, Hon. Members, we turn back to Article 257 (6), which provides, and I reiterate, that if a county assembly approves the draft Bill within three months after the date it was submitted by the Commission, the Speaker of the county assembly shall deliver a copy of the draft Bill jointly to the Speakers of the two Houses of Parliament, with a certificate that the county assembly has approved it.

Hon. Members, The BBI (Constitutional Amendment) Bill, 2020 is therefore admitted and properly with us and stand committed to the committee on Labor, Social Welfare, Justice and Legal affairs.
