The Speaker, (Mr. Solomon Lempere): Hon. MCA Lodokojek Ward, (Hon. Jerias Leshoomo): Thank you Hon. Speaker, point taken. Hon. Speaker I support the report of the Committee on Appointments on the vetting of the nominee Ms. Peinan Loronyokwe for the position.

Mr. Speaker during vetting we found the nominee fit for the position because she has the ability and requisite qualifications as stipulated in the County Government Act ,2012 section 25 (3).
