PETITIONS

Temporary Speaker, (Hon. Doris Lenkirasi): Hon. Members we received a petition from the Kirisia Forest Community Forest Association (CFA). It is a petition of Samburu on matters raised in the FY 2021 County Fiscal Strategic Paper -Water, Environment, Natural Resources and Energy sector.

"We the undersigned citizens of the Republic of Kenya, tax payers, members of community forest association and residents of Samburu County draw the attention of the County Assembly to the following:

1. Charcoal burning.

- 1.1.THAT, there has been rampant destruction of forest through charcoal burning that requires enforcement of the National Forest Conservation and Management Act.
- 1.2.THAT, the Community lacks alternative sources of livelihood resulting in their involvement in charcoal burning.
- 1.3.THAT, public sensitization exercise needs to be enhanced to create public awareness on the dangers and effects of charcoal burning.

2. Overgrazing.

THAT, there has been overgrazing on pasture lands that calls for capacity building to grazing user groups.

3. Sand harvesting.

THAT, there has been no clear policies and procedures on sand harvesting exercises in Samburu County.

4. Human-wildlife Animal conflicts.

THAT, there has been an increased lack of public awareness for compensation and proper reporting procedure for survivors of human-wildlife animal conflicts.

5. Illegal Cider poles chopping.

THAT, there has been inadequate safe spaces and camps for CFA forest scouts to guard against increased cider poles chopping.

6. Forest fires as a result of honey harvesting.

THAT there have been rampant incidents of fires as a result of rudimentary honey harvesting technologies.

- 7. THAT, we have made the best efforts to have these matters addressed by the relevant authorities all of which have failed to give us a satisfactory response.
- 8. THAT, none of these issues raised in this petition is pending in any other court of law, constitutional or any other legal body.

WHEREFORE, we your humble petitioners pray:

1. THAT, the County Assembly of Samburu consider revising the Medium-Term Expenditure Framework (MTEF) environment sector ceilings 2021/2022 on page 56 of the draft County Fiscal Strategy Paper.

The revision will increase local revenue from the environment sector significantly as contained in the local revenue analysis by Department; table 2 page 52 refers, Department ceilings and criteria for resource allocations (table 7 page 105 refers).

- THAT the County Government of Samburu initiates the process of domesticating the Kenya Forest Conservation and Management Act to Samburu County Forest Conservation and Management Bill and policy to:
- 2.1) Recognize and employ voluntary scouts and informers from CFAs.
- 2.2) To collaborate with CFAs to manage community forest under Article 63 (3) chapter 5 of the Constitution of Kenya.
- 2.3) To promote high value fortress for farmers in the village to mitigate against charcoal burning.
- 2.4) To enhance law enforcement to perpetrators of charcoal burning.
- 2.5) To capacity building grazing user groups on effects of overgrazing in pasture lands.
- 2.6) To enhance public sensitization and awareness of sand harvesting.
- 2.7) To establish a sand harvesting policy to provide sustainable exploitation of sand resource.

- 2.8) To facilitate formation of sand harvesting user groups under CFAs.
- 2.9) To promote public awareness and sensitization on proper reporting procedures for human-wildlife animal conflict survivors.
- 2.10) To jointly with jointly with key stakeholders to create adequate safe spaces and camps for CFA forest scouts and volunteers to guard against increases cedar poles chopping.
- 2.11) To expose honey harvesters to new and modern honey harvesting technologies that promotes forest conservation and improve livelihood through empowered world view approaches.

Every person has the right to have access to health care services, including reproductive health care. No person may be refused emergency treatment.

In relation to health care services, this means that government must:

Respect the right of access to health care services by not unfairly or unreasonably getting in the way of people accessing existing health care services, whether in the public or private sector.

Protect the right by developing and implementing a comprehensive legal framework to stop people who get in the way of the existing access of others.

Promote the right by creating a legal framework so that individuals are able to realize their rights on their own.

Fulfil the right by creating the necessary conditions for people to access health care, by providing positive assistance, benefits and actual health care services.

Madam Speaker, Healthcare delivery has several categories;

- 1. Community level.
- 2. Dispensaries, which is the second tier
- 3. Health center

4. Low volume district hospital (previously referred to as District Hospital and in our case Samburu County Referral Hospital. is included)

- 5. High volume
- 6. National Referral Hospital

Madam Speaker, the Committee had several findings in relations to the above.

From the discussion with the technical staff from the department and partners, the Committee made the following observations and findings - That, The 200 million for lease of equipment's is consuming much of the department. Madam Speaker, we had variety of findings. The House can still go through it and make their contributions thereafter.
