STATEMENT ON CREATION OF MORE DEPARTMENTS BY THE EXECUTIVE

Leader of Majority, (hon. Christopher Lentukunye): Thank you hon. Speaker, there was a statement sought by hon. Wonyang' concerning creation of extra offices. I did request that I need more time so that this response can be tabled before this House but since the authorities concerned are out of the country for official duties, I still request for more time so that this statement can be tabled before this House on Wednesday next week, thank you.

The Deputy Speaker, (hon. Jonathan Lemoosa): **I** do not agree with the Majority Leader because for once we need to be serious when it comes to statements. The statement has been referred two times now and as the Majority Leader has answered, we know that H E the Governor just left the other day. We therefore should be serious in responding to statements and this is a matter that needs to be looked into, thank you.

The Deputy Speaker, (hon. Lemoosa): What is it hon. Lorunyei?

MCA Nachola Ward, (hon. Lawrence Lorunyei): According to the statement, where need arises, we look for the solution. If the Executive saw the need of having another extra office, and request this hon. House to approve, then I think it has no harm, however, I request for your guidance. My question is, do we need a response from the Executive which came up with the idea of an extra office? Or should we; put a Motion as a result of the need of the upcoming office. It is true our county has a problem of water, so, how do we tackle the issue now that the department of water is one of them? Thank you.

MCA Ang'ata Nanyokie Ward, (hon. Paul Leshimpiro): We are not in a position to say the county government not or the Executive does deserve to have those offices but what the statement was requesting was, why was it created without following the right procedure. Unless we are told you did approve those offices before the election. If that was not the case, the whether the need was there or not, the procedure used was the one we are questioning.

The Deputy Speaker, (hon. Lemoosa): Hon. Members, the hon. Lawrence Lorunyei was requesting to understand and get guidance from the Chair whether it is the House or the

Executive that should approve the establishment of the extra offices. But I want to be guided by the County Government Act and the Standing Orders that of course the need to create any office is originated by the Executive; the Public Service Commission having in mind the budget and all that pertains to create an office.

The work of this hon. House is just to approve and because the executive has seen the need, and they have come up with the offices that the hon. Wonyang' wants to understand, guided by those facts (that it is the Executive that creates offices), and ours is to approve, then the hon. Majority Leader has a point that these answers are not forthcoming now because the authority concerned are not around. To me it is not demeaning the House but because the County Secretary, who is in charge (the CEO) of the government, whom the Majority Leader would have liaised with to get the needed answers, is not around. Why then don't we agree and give the Leader of Majority more time to engage and bring sufficient answers?

MCA Nachola Ward, (hon. Lorunyei): In the department of Water, the CEC was hon. Lekupe. May be he saw the need of creating another office to separate water from his department and it did not go outside. It was not the Governor who initiated but the office applied to the County Service Board for its creation. The Governor is just there for approval.

The Deputy Speaker, (hon. Jonathan Lemoosa): I will give guidance on that. hon. Lesoipa.

MCA Suguta Marmar ward, (hon. Shadrack Lesoipa): Thank you Mr. Speaker Sir. When you start advertising and interviewing the nominees, the budget must inform all the processes that you do. As we wait for the supplementary, you cannot purport to supplement a budget that was meant for development just to recruit an already burdened wage bill on the county government. It is the previous budget that will inform the advert and subsequent interviews of the said nominees. It is wrong to advertise and interview people for offices that will cost more than Kshs.60 million that is not informing the budget. That is an illegality but they can go ahead and identify the need to convince this House why they are creating such an office. As we stand now, there is no budget to support the recruitment.

The Deputy Speaker, (hon. Jonathan Lemoosa): Hon. House, I think we are guided by the Standing Orders that clearly states that we should not anticipate debate. I want to give some

insights to the Members in accordance to the Standing Order number 46, (1) to (4), on approval of public appointment committal to committees.

- 1. Upon receipt of notification of nominees for appointment to an office, under any legislation required to be approved by the assembly, the nominee shall stand committed to the sectoral committee of the assembly for consideration.
- 2. Despite paragraph 1 clause 1, appointment under article 179, (2)(b) of the Constitution shall stand committed to the Committee on Appointment.
- 3. Before holding an approval hearing, the committee to which proposed appointments have been referred shall notify the candidate and the public of the place and time for holding the approval hearing seven days before.
- 4. The committee shall conduct the hearing.

I want to believe by creation of a division, and speaking as a CEC, I know that this House does not deal with a CEC but it should be furnished by the County Secretary of such hefty matters. But this does not mean that the separated departments from the ministry had no budget. Let us not anticipate that. I want to direct and rule that as a House we put aside all this and give the Majority Leader until Wednesday next week to come from that particular hearing. Let us continue to the next order.

Majority Leader, (hon. Christopher Lentukunye): Thank you hon. Speaker. I believe the hon. Member is a senior Member of this House; every Member is aware of the House calendar. This is our last day. The next sitting is on Tuesday next week. Nothing is new. Mr. Speaker I need to consult with you first.

The Deputy Speaker, (hon. Lemoosa): Yes.

Majority Leader, (hon. Christopher Lentukunye): Thank you Mr. Speaker. I beg to continue. As I said earlier, this is the last day of our plenary.
