(Point of Order by Hon. Benjamin Leitore)

MCA Wamba West, (Hon. Benjamin Leitore): In reference to Standing Order number 61, I think that it speaks on the removal of the Speaker.

MCA Elbarta Ward, (Hon. Peter Lempei): Mr. Speaker, I think I was referring to the page.

The Temporary Speaker, (Hon. Shadrack Lesoipa): You are totally out of order.

MCA Wamba West, (Hon. Benjamin Leitore): I refer my learned friend and the hon. Member for Elbarta to Standing Order number 151 please.

MCA Elbarta Ward, (Hon. Peter Lempei): I went by the page and not the specific number of the Standing Order. I am glad that the Speaker is not here because it would have been as if I am moving a motion for his removal.
