ADMINISTRATION OF OATH

The Speaker, (Hon. Fred Lengees): Hon. Members, in accordance with Standing Order No. 26 (3) a gazette notice was published to convene this Special Sitting to swear in Members who had not been sworn in during the first sitting on 28th September, 2022 pursuant to Standing Order No. 3.

Hon. Members, Standing Order No.3 (4) provides as follows: - "*Pursuant to Article 74 of the Constitution, no person shall assume or perform any functions of the office of a County Assembly before taking and subscribing to the Oath or Affirmation of Office* provided for under paragraph (3)." Article 74 of the Constitution, which is actualized by the above standing order state as follows;

"Before assuming a State office, acting in a State office, or performing any functions of a State office, a person shall take and subscribe the oath or affirmation of office, in the manner and form prescribed by the Third Schedule or under an Act of Parliament".

Hon. Members, Standing Order No.3 (7), the following procedure shall apply for the administration of oath or affirmation of office to the members, and it states as follows;

When a member first attends to take his or her seat after the first sitting of the county assembly, the member shall, before taking his or her seat be escorted to the table by two members and be presented by them to the Speaker who shall then administer to the member the oath or affirmation of office.

Hon. Members, pursuant to Standing Order No.3 (2) (c) I shall now proceed to administer the Oath or Affirmation of Office to all Members here present who were not sworn in. Hon. Members, we are now ready to commence the process. Clerk at the Table, kindly continue.
