Temporary Speaker, (Hon. Stacy Nareyo): Response for Statements; it is notified that the following Statements are due for response today Thursday, 24th November, 2022 at 2:30pm Pursuant to Standing 45(C);

- a. Statement No. 013/2022 from Chairperson Sectoral Committee on Education and Vocational Training Regarding the status of the disbursement of bursary for the financial year 2022/2023 and the recent appointment of the Bursary Coordinator by the Governorrequested by Hon. Francis Lemartile, MCA Wamba West Ward
- b. Statement No. 014/2022 from Chairperson Sectoral Committee on Agriculture, Livestock and Fisheries regarding the tender notice Issued to the Public on 11th November, 2022, on supply and delivery of Somali Camel breeds, Sahiwal breed cattle bulls, heifers and calf Ayrshire breed cows - requested by Hon. Ali Lealmusia, MCA Ndoto Ward

Vice Chair, Committee on Agriculture, Livestock and Fisheries, (Hon. Silapia Lenamatiyio): Thank you Madam Speaker, I stand to give response to the statement sought by Hon. Ali Lealmusia, MCA Ndoto Ward. The questions are;

- **1.** Is it wise for the County Government of Samburu to purchase and supply these livestock breeds to the residents of Samburu during a severe drought?
- 2. Is the purchase and delivery of these livestock breed a priority for the department considering it should focus its efforts on drought mitigation measures to save already starving livestock?
- 3. Is the Department considering supplying these breeds with feeds to ensure their survival? Then the response; Hon. Speaker, since the procurement of these animals, was approved during the County Executive Meeting Budget deliberations on Supplementary No. 1 and consequently approved by this House, the Department had no choice but to continue with the implementation of these projects as per the Approved Budget Supplementary No. 1. A copy is hereby, attached for your reference. You will agree with me that changing the budget again to propose new projects, which are, not weather-related may raise budget cycle questions since the process will

require community participation with time and cost implications. I would like to inform you that the procurement of these animals is a long process as provided for by the Public Procurement and Disposal Act, 2015, and we can still continue with the procurement process of the breeding animals. The supply and delivery of the animals will happen between the months of March and April 2023. March to April is usually a wet season and we are optimistic that we might receive normal rainfall enough to permit the re-generation of pastures and browse materials unless otherwise informed by the Meteorological weather outlook report by then.

Below is the procurement stages and dates for your reference.

Procurement stages

- 1. Advert Notice 11th November, 2022
- 2. Submission and opening of the tenders 21st November, 2022
- 3. Tender evaluation and reporting -22^{nd} December, 2022. Not more than 30 days.
- **4.** Issuance of professional opinion by the Head of the Supply Chain Management 27th December
- **5.** Award decision issued by the Chief Officer Agriculture, Livestock and Fisheries 28th December, 2022.
- **6.** Notification of Award and regrets issued by the Officer Agriculture, Livestock and Fisheries 17th January, 2023. 14 days' standstill.
- 7. Contract signing and issuance of Local Purchase Order(LPO) 20th January, 2023.
- **8.** Supply of the animals and inspection by the appointed Inspection and Acceptance Committee. 21st April 2023. Given a minimum of three months to deliver animals.
- **9.** Delivery and distribution of the animals to the beneficiaries -22nd -23rd April 2023. A minimum of 20 days.
- **10.** Payment of the Supplier- latest 30th June, 2023.

Madam Speaker, looking at the procurement stages and process, it will go until 2023 for the Supplier to supply the animals. So the process will be very long. Hon. Madam Speaker, in the event the Weather Outlook predicts that there will be a delay in the onset of March-May long rainfall season, then the next option would be to hold the received animals at Nomotio LIC for a while or temporarily. At the farm the animals will require feeds, water and vet drugs to maintain then for at least two months or less depending on the performance of the weather conditions

then. This Committee therefore appeals to the County Executive Committee and this House to reallocate more funds during the Budget Supplementary No. 2 meeting to procure the needed feeds, water and vet drugs to sustain the received animals for two months. The farm management will provide the budget before then, thank you Madam Speaker.
