#### PROCEDURAL MOTION

**Chairperson Budget and Appropriation Committee,** (Hon. Lemoosa Jonathan): Thank you Hon. Speaker. Hon. Speaker, I beg to move the following Motion:

**THAT**, the County Assembly exempts the Samburu County Supplementary Appropriation Bill, 2023 from the provisions of the Standing Order 128 to exempt committal of the Bill to the relevant Committee and public participation. I beg upon Hon. Nakinyi to second. Thank you Hon. Speaker.

(Hon. Nakinyi bows to second the motion)

**The Speaker,** (Mr. Lengees Fred): Hon. Members, I now propose the Question, **THAT**, the County Assembly exempts the Samburu County Supplementary Appropriation Bill, 2023 from the provisions of the Standing Order 128 to exempt committal of the Bill to the relevant Committee and public participation. The floor is open for debate.

**Leader of Majority,** (Hon. Lentukunye Christopher): Thank you Hon. Speaker. Mr. Speaker, I stand to oppose the exemption of this document to the relevant Committee as you have proposed before this House. Mr. Speaker, it has been a tradition of this House, and this House must not set such kind of precedence where things, especially to do with money issues are brought when we are in hurry and we move such motions exempting the document going through the whole process. So Mr. Speaker for that reason I stand to oppose.

Chairperson Budget and Appropriation Committee, (Hon. Lemoosa Jonathan): Hon. Speaker, I stand to beg your office as the Chair and the Hon. House to accept the exemption plea because the Hon. Members of the Committee and the House had a long time with the document. It was submitted to the House on 28<sup>th</sup> February,2023 whereby the Committee on Budget interrogated the document even before the cabinet approval. Thereafter, we had subsequent interrogation of the document with the Members of the County Assembly to give life and much wanted view or embracement of the paper to the Committee. And as such therefore Mr. Speaker,

I beg the Hon. House to accept the exemption since we have had this paper for long time. Thank you.

MCA Angata Nanyokie Ward, (Hon. Leshimpiro Paul): Thank you Hon. Speaker and I rise to oppose the proposal that this Bill be exempted from being committed to the relevant Committee and thereafter the public participation.

Hon. Speaker, this supplementary budget has attracted a number of interests, and it is prudent because there were a lot of issues raised by Hon. Members and the public that this Bill be submitted to the relevant committee and be subjected for public participation for the purposes of correcting what the Hon. Members of this House and the public wishes to air their views on, add or delete factors that are raised upon in that Bill.

Secondly Hon. Speaker, I do not think we have other big Bills other than the money Bills that every now and then we have made a tradition that we always exempt. We always exempt. What do I know that I am exempting? First of all Hon. Speaker, this Bill is brought here in block figures. It is just in block figures; the Department of Health will have this amount of money as recurrent. They will have this amount of money as development (capital expenditure), but what is in that recurrent? There is not line item. And if we are still the Hon. House that is supposed to represent our people, legislate and to oversight, then we do not know what we are oversighting if you are given a block figure. If I take for example, any department and you quote the figure that would be used in recurrent then you say that is very much in order, what is in order when you don't know what is contained in it? You need to understand the nitty-gritty inside that block figure so that you can make a conclusive informed choice of that budget.

Hon. Speaker, I do not want us to become a rubber stamp House because that is where we are heading to; to be brought anything whether it is bitter or sweet, what is expected of us is only to swallow. That is unhealthy, unethical and it is not what the people of Samburu County chose or nominated us to come and do. So I oppose and I humbly request that this House be honourable by committing this Bill to the Committee and thereafter subject it for public participation, and everybody will be comfortable and we will approve the money Bill as required. Thank you Hon. Speaker.

MCA Loosuk Ward, (Hon. Lenamparasio Caunda): Thank you Hon. Speaker. I rise to support the exemption of this Bill to the relevant Committee and public participation. Mr. Speaker Sir, as Hon. Lemoosa has just said because I sit in the Committee on Budget, a number of times throughout what we usually call the *Kamukunji*, we had a number of *Kamukunjis* here with this Bill for the whole House. I think the Chairperson of Budget even provided the whole House with some spreadsheets of what had to be supplemented. Hon. Speaker, as much as I do not agree that we should be used as a rubber stamp, but again we have to look at the issue of time. Mr. Speaker, if you look at what is being supplemented; it is just some very little money. A number times through those *Kamukunjis* the issues raised by Members here, I think we had some of them rectified. Being representatives of the community who elected us here, I think we are in good terms to maybe agree or disagree here on anything through representation because that is what the law has provided us, that we can represent the people, we can do the oversight and legislate. So Mr. Speaker, I beg this House to allow the exemption of this Bill to the relevant committee and public participation. Thank you Mr. Speaker.

The Speaker, (Mr. Lengees Fred): Hon. Lemoosa, what is your point of order?

Chairperson Budget and Appropriation Committee, (Hon. Lemoosa Jonathan): Mr. Speaker Sir, I stand on a point of information that is in line with what Hon. Lenamparasio has given. The information I want to rely across is I want to believe every Member is supplied with a Bill and alongside what proposals are forwarded is attached to it. And please, if you have not seen, then I beg a leave such that our clerks please supply Members with the proposals.

Secondly Mr. Speaker Sir, why it is important to exempt this particular supplementary Bill to public participation; it is actually in line with Public Finance Management Act, 2012 section 39 (9), and with your permission I want to read;

In approving any estimates under section 135 and 154 of the Act, the County Assembly approves shall not exceed 10% of the approved budget estimates of program of sub votes unless it is unforeseen and unavoidable as defined in section 112 of the PFM.

Speaker, the budget has already been subjected to public participation, and in this order the Assembly is only, only subjected to amendment of 10%. 10% cannot call for public participation. Thank you.

The Speaker, (Mr. Lengees Fred): Hon. Members, I now put the Question, THAT, the County Assembly exempts the Samburu County Supplementary Appropriation Bill, 2023 from the provisions of the Standing Order 128 to exempt committal of the Bill to the relevant Committee and public participation. (Question put, and the Motion; to exempts The Samburu County Supplementary Appropriation Bill 2023 from the provisions of the Standing Order 128 to exempt the Committal of the Bill to the relevant Committee and public participation agreed to)

(Five Members in disagreement to the Motion stand after the Chair made the ruling. The Chair recognizes them)

MCA Angata Nanyokie Ward, (Hon. Leshimpiro Paul): The point of order is if we are in disagreement with the decision you made of the Ayes' and Nays', then the next thing is to go for voting itself. Thank you.

**The Speaker,** (Mr. Lengees Fred): Hon. Members, according to the Standing Orders the Ayes' have it. Because you stood after I announced the Ayes' have it.

# THE SAMBURU COUNTY SUPPLEMENTARY APPROPRIATION BILL, 2023—Second Reading

Chairperson Budget and Appropriation Committee, (Hon. Lemoosa Jonathan): Thank you Hon. Speaker Sir. Hon. Speaker, I beg to move the following motion, **THAT** the Samburu County Supplementary Appropriation Bill, 2023 be now read a second time. I call upon Hon. Kagiri to second. Thank you Speaker.

#### (Hon. Kagiri bows to second the Motion)

**The Speaker,** (Mr. Lengees Fred): Hon. Members, I now propose the Question, **THAT**, the Samburu County Supplementary Appropriation Bill, 2023(Samburu County Bill No. 1) be read the second time.

MCA Angata Nanyokie Ward, (Hon. Leshimpiro Paul): Hon. Speaker, I do not think you are fair to this House that we raise hands, we want to contribute and you not giving us the opportunity to do so. That is so unfair. We all have rights. You can decide whatever you wish to decide thereafter.

**The Speaker**, (Mr. Lengees Fred): Hon. Leshimpiro, according to the Standing Orders and the commonwealth rules, the Speaker does not have eyes to see. So I continue as I wish as per the rules.

Hon. Members, I now put the Question, **THAT**, the Samburu County Supplementary Appropriation Bill, 2023 be read the second time.

(Question put, and the Motion; the Samburu County Supplementary Appropriation Bill, 2023(Samburu County Bill No. 1) be read the second time agreed to)

Chairpers Committee of the Whole House, (Hon. Lelenkeju Jackson): Order Hon. Members! Resume your seats. Hon. Members, the House is in session. I now direct the clerk to proceed.

**Chairperson Committee of the Whole House,** (Hon. Lelenkeju Jackson): Hon. Members, I now propose the Question that clause 3 be part of the Bill as read by the clerk.

Chairperson Committee of the Whole House, (Hon. Lelenkeju Jackson): Hon. Members, I now propose the Question **THAT** codes R4211 to R4221 for recurrent expenditure be part of the Bill.

MCA Angata Nanyokie Ward, (Hon. Paul Leshimpiro): Thank you Hon. Chair. Chair, I just request that we be a bit objective rather than be subjective and being used as rubber stamp as I said before. I have one concern so that you can take the budget as you so wish, that R4220; the amount required in the year ending 30th June 2023 for the Salaries and expenses for the Department of Tourism, Trade, Enterprise Development and Cooperatives 216, 509, 851. Chair, I just propose that one of the most affected areas is Baragoi, the vehicle for the rangers has been removed and taken to Poro. Poro had a budget for a new vehicle but it is not appearing in any of this. We are given a paper that has amendment but no amendment has been read while this entire column has been read. So at what time will it be? So my proposal and I just want us and request we be objective. I request that the budget for the rangers' vehicle for Porro be included in that figure, and we put the Question after that amendment. That is my humble request, if everything has become that you don't have the eyes.

#### (Chair consults the clerk at the table)

Chairperson Committee of the Whole House, (Hon. Lelenkeju Jackson): Hon. Leshimpiro, guided by the Standing Orders of this Hon. House, you have a valid point but I think there is a procedure through which we do that. If you have any amendment that need to be considered in this particular Bill at this stage, you require to publish the proposed amendment to be approved prior to the House sitting.

MCA Angata Nanyokie Ward, (Hon. Leshimpiro Paul): Hon. Chair, with due respect, these were the things we proposed and somehow were agreed upon only to appear that they were not amended. So when will I have time to put it in writing while it is not required? It is just that I do not have the eyes to see it. I do not want to see it here. I think as House, we have the possibility of making some corrections. So we should not enclose ourselves as slaves. The rules are there to help us, not us to help the rules.

MCA Elbarta Ward, (Hon Leitoro Jeremiah): Hon. Chair, thank you very much for giving me this opportunity. Hon. Chair, I want to echo whatever Hon. Leshimpiro has said. As we speak, the people of Elbarta have no rangers' vehicle because the vehicle was moved from Baragoi to Pura. Hon. Chair, I am in support for the Hon. Member for Poro to be given a new rangers' vehicle so that they can be able to release my vehicle to go to Baragoi. As we speak Hon. Chair, we have issue of insecurity, and I am here to represent the people of Elbarta Hon. Chair and I never sit here when my people are suffering. So Hon. Chair, I request that we amend to add the amount that is required for buying new rangers' vehicle. Thank you Hon. Chair.

The Leader of Minority, (Hon. Leleruk James): Mr. Chair, we are here to represent the people and also to make some rules. I know the reason some of us are forcing this issue of rushing but I will not be part of rubber stamping. On 9<sup>th</sup>, there were some amendments we proposed, and the Bill that is here before us has been received on 3<sup>rd</sup> way before we proposed the issues we had. One of the issues was boreholes and the issue of Poro. We are not asking much on this Bill. We are just asking that Poro insecurity issue is a threat to all of us as Samburu County, and if as the elected leaders we cannot protect our people then there is no business we are sitting here as say we have no eyes to see. All these Members of the County Assembly of Samburu; we are not opposing what need to passed. What we are opposing are things that are not seen clearly.

The second issue is pending Bills. As a County Assembly, we must know these pending bills that is being paid; who are we paying? Are the projects true? The other day here we were complaining of some boreholes paid and no development was done when ee are just standing here, and passing these issues yet before us we have so many issues of pending bills. That is the

reason I am standing here opposing this Bill. And if you take your way, let the people of Samburu know that some of us we were not elected to come and rubber stamp. Thank you

**Chairperson Committee of the Whole House,** (Hon. Lelenkeju Jackson): Hon. Members, I refer to Standing Order 133 (2) that reads;

No ammendment shall be moved to any part of a Bill by any member other than the member in charge of the Bill unless written notification of the amendment shall have been given to the clerk 24 hours before the amendment of the sitting at which that part of the Bill is considered in the committee.

Now I propose to put the Question. What is Hon. Leshimpiro?

MCA Angata Nanyokie Ward, (Hon. Leshimpiro Paul): Hon. Chair, I requested that we consider matters objectively. Hon. Chair, the use of that vehicle is very important. It saves lives, and here we are being told the Standing Orders cannot all us. So it simply means that the Standing Orders have been accepted to allow the death of people. That we have become slaves of Standing Orders. And here we are saying give us the exemption of this Bill. Why then is it not applied everywhere?

I find some times these Standing Orders are so strange; that we allow people to die because we are following Standing Orders and yet we can just amend it. It says with the leave of the House that means if we agree as a House, we can amend it. But then we are just so selfish that we don't care the impact of that vehicle. The need of that vehicle, we do not see it. We push people to fight, we do not given them the resources to defend their selves and here we are just coming to say the Standing Order does not allow. These Standing Orders considers the exemption. It considers with the leave of the House. That means we can agree as House that we do not have a problem with Porro being given a rangers' vehicle. What is wrong with that? It is so strange and very bad way to take things.

Just because we were ordered by the Executive to pass this Bill, it makes us blind to see even the basic things. We moved money from Health, 26 million. Archers Post has no theater and it has a complete hospital. Wamba Health Center does not have a theater. You removed money from Disclaimer: The electronic version of this Hansard report is for information purposes only. health to go and build perimeter walls. That is a shame that we do not have priorities as county right. We don't. Baragoi has completed theater and we are removing money from Health to go build perimeter walls, to protect who?

Look at this, we have rangers. We have given them salary, the national government has gone ahead to give them guns. What is the essence of these guns? It is to protect the community. Here we are being told the priority of Samburu County is to make a fortified perimeter wall to protect the rangers. When will they go to protect the people if they themselves are protected with a perimeter wall and they have guns? When will a mother in hut, in a small *Lokol*, when will she be protected? If the enemy/bandit can count how many people are in that House, and he chooses where to shot, whether the head or heart or anywhere, and we are prioritizing perimeter walls in the middle of nowhere. No people. We are taking money from health to build perimeter walls. Is that a real priority?

I humbly request that we make this consideration; give Poro a rangers' vehicle.

MCA Poro Ward, (Hon. I see that there are recurrent ammendments and the Chairperson has not read. The Chairperson should have read otherwise it will lose meaning, it will just be a paper to fool us.

Chairperson Committee of the Whole House, (Hon. Lelenkeju Jackson): Hon. Leshimpiro I do not see any recurrent ammendment, I only see ammendments in the Development schedule and we are not there yet.

My people are suffering Mr. Speaker, just two days ago a number of goats were stolen; the rangers and Kenya Police Reserve(KPR) were forced to walk for the recovery mission which is very dangerous.
