MCA Elbarta Ward, (Hon. Leitoro Jeremiah): Hon. Speaker I stand to ask for the following statement:

Hon. Speaker Pursuant to Standing Orders 45 (c), I hereby request for a statement from the Chairperson Committee on Environment, Water and Natural Resources in regards to garbage collection in Baragoi town.

Hon. Speaker, the rapid urbanization that has been taking places during the 20th century virtually transformed the world into communities of cities and towns facing similar changes on environmental issues in which most of them have to be addressed at international level (Smith, 2010). Among those environmental issues solid waste management is critical one because as long as humans have been living in settled communities, solid waste generation has been an unavailable and critical issue both in developed and developing nations. As a result, solid waste management became a worldwide agenda at the united nation conference on environment and development.

Hon. Speaker, Baragoi town is rapidly growing with a lot of population and businesses growing day by day hence garbage collection services are needed.

Hon. Speaker, in view of this; the Chairperson should inquire into and report on:

- 1) What are the plans of garbage collection in Baragoi town? If any, does the Department has any plans recruiting more service providers? Is there any timeline for the above?
- 2) Does the Department have any plans of renewing those who are on contract basis?

Hon. Speaker, as I speak; there was a contractual agreement between the Samburu County Government by the name Mr. Kikuri Mawaitho who was collecting garbage at Baragoi town and the contract ended in December, 2022 and there were no plans to renew the contract Hon. Speaker and since then garbage collection became an issue.

I am contented although it is still not at a 100%. I can say that we are not where we were as a Health facility but at least we are somewhere. The facility provided all the assistance to stabilize the Honorable Member by use of the X Ray, Ultra Sound, CT scan, the operations, ICU and the transportation. We thank the County Assembly for having an effective insurance (AAR Insurance) we have seen it today, thank you for everything.
