Members I now propose the question **THAT**, pursuant to the provision of Standing Order No.217 (6) this County Assembly adopts the report of the County Budget and Appropriation Committee on the budget estimates for the County Government and the County Assemblies tabled in the Assembly on 2<sup>nd</sup> May, 2023.

Chairperson, Committee on Budget and Appropriation, (Hon. Lemoosa Jonathan): Thank you the Hon. Speaker Sir. The Hon. Speaker Sir, I wish to bring attentions to the Hon. Members of the report on the County Estimate of Revenues and expenditure for the Financial Year 2023/2024. Speaker sir, the legal framework, Speaker this is a report on annual Estimate of Revenue and Expenditure submitted by the County treasury on 28<sup>th</sup> April, 2023 for the Financial Year 2023/2024, the proposal are submitted in the accordance to Section 129 of the PFM Act 2012 which **THAT**, states, the County Executive Committee member to submit Budget Estimate and other Documents to:

- 1. County Executive committee for approval 129 (1) County Executive Committee member of finance shall submit to the County Executive Committee for its approval:
- **a**. The budget estimate and other documents supporting the budget of the County Government excluding the County Assembly.
- **b**. The draft bill at the County level requires to implement the County Government budget in sufficient time to meet the deadlines prescribed by this section.
- 2. Following approval by the County Executive Committee, the County Executive Committee shall, member for finance shall:
- **a**. Submit to the Assembly the budget estimate supporting documents and any other bill required to implement the budget except the finance bill by 20<sup>th</sup> April in that year and ensure that the estimate submitted in subsection A are in accordance with the resolution adopted by the County Assembly, all the County Fiscal Strategy Paper.

- 3. Each County Assembly clerk shall prepare and submit to the County Assembly, the budget estimate for the County Assembly and a copy shall be submitted to the County Executive Committee member for finance.
- 4.The County Executive Committee member for finance shall prepare and present his or her comments on the budget estimate presented by County Assembly Clerk.
- 5. The County Executive Committee Member for finance shall ensure that, the budget process is conducted in a manner and within a time frame sufficient to permit the participants the process to meet the requirements of the constitution and this act.
- 6. As soon as possible, after the budget estimate and other documents have been submitted to the County Assembly under this section, the County Executive Committee for finance shall publish and publicize the document.

#### **INTRODUCTION 1:0.**

The Samburu County estimate for the financial year 2023/2024 was submitted to the County Assembly on 28<sup>th</sup> April 2023, tabled and deemed committed to the Sectorial Committee on 2<sup>nd</sup> May 2023. Mr. Speaker sir, the Committee on Budget and Appropriation thereafter, proceeded to examine and deliberate on proposal estimate and come up with recommendation which are contained in this report.

Speaker sir, the Committee recommendations were arrived at during Committee meetings and consultations with the County Executive. Upon approval by the honorable House, the resolution contained in this report will form the basis for the appropriation bill for the financial year 2023/2024.

Mr. Speaker sir, this report has been divided into four main sections, namely;

- i. Revenue basket with three components: Equitable share, County owned revenue and Grants.
- ii. Recurrent expenditure: Personal emolument, Operations and maintenance, Funds and recurrent grants.
- iii. Development expenditure: Development grants and Ward priorities,

iv. Revenue framework. Speaker, revenue framework 2 (0) is stipulated in the table 2 (1), 2 (2)

An observation Mr. Speaker sir, observation of the resource basket.

- I. The total estimated revenue for the financial year 2023/2024 is 7,268,830,376.
- II. In the financial year 2023/2024 the equitable share of revenue donates the largest share revenue at 76.88% while conditional grants translate to 9.72%. On source revenue at 3.52% and projected and spent balance of 9.88% as tabulated below. (The figures and the table tabulating are underneath).
- III. The equitable share of revenue Mr. Speaker sir, increased from 5,371,346.37% in financial year 2022/2023 5,588,175, 670 shillings in the financial year 2023/2024 thus an increase in Ksh. 216,829, 633.
- IV. Conditional grant has increased from 35,957,243 shillings in financial year 2022/2023 to Ksh.706, 627, 306 in financial year 2023/2024 as tabulated below. (The table Speaker sir is underneath).
- V. The local revenue has been projected at 256, 027, 400 for financial year 2023/2024. Speaker sir, 3(0) consolidated County expenditure for the financial year 2023, Mr. Speaker sir the committee recommended that total recurrent expenditure of Ksh. 4,575,112,076 to fund personal emolument, support operations routine maintenance, funds and recurrent grants.

(The table below is a summary of County consolidated expenditure estimate for the financial year 2023/2024. The table underneath explains).

#### **Local Revenue 3:2**

Mr. Speaker, the committee recommends a total overhaul of the revenue collection system to embrace technology to ensure that it is easy, efficient and effective to encourage payment of revenue and accountability of the collected revenue as well as collection of non-remitted revenue.

#### **Development Expenditure 4:0**

Mr. Speaker sir, the committee recommends to finance development programs in the financial year 2023/2024 as summarized in the table below. Table four, Speaker sir explains how development expenditure is spread within the county all through page 18,19,20,21,22,23,24 Speaker sir and 25.

#### **Recommended Development Inclusion 4:1**

Mr. Speaker sir, upon consultations, with relevant departments the committee recommended the following items to be estimated that, in consideration to the County government additional allocation bill published on 24th May 2023 the summary of what was focused in the budget and what the bill proposes are shown below.

We have the revenue transfer of National government, conditional grants, leasing medical equipment, DANIDA mineral royalties, risking and value enhancement, fertilizer subsidy, agriculture sector, Kenya Livestock Commercialization project, locust, balance brought forward and finance led to climate action programme of FLLOCA.

The bill amount of Ksh. 2,000,000 has counter fund for the World bank loan for the National agriculture and rural inclusion growth project. The committee recommends the incorporation of changes in the County budget of revenue expenditure of the Financial Year 2023/2024.

That in the consideration sectorial on Water Environmental, Climate Change, Natural resources and Energy the Committee on Budget and Appropriation made the following observation:

a. That during the Budgeting process the department realized some of the critical components have been dropped off we request the County Assembly to consider having been rebudgeted some of the components that were dropped have some implications on Donor Funding since they are required to counterpart funding Department for example is implementing a World Bank Funded Program financing local laid climate action of (FLLOCA) which is a performance for results program requires the participating counties meets some minimal performance conditions (MPCS) one of such conditions is that the County allocates the counterparts and or marching fund for the program.

b. Be in line with Samburu climate change Act 202, and FLLOCA requirement The Governor has committed to allocate Ksh.40 million in which 1.5 the County Development Budget to support climate change action as counterpart funding for the financing locally led climate change or action (FLLOCA) program.

The committee recommends that the following as per the department request;

- 1. The allocation of proposed funding amounting to 5.9 million to the department of Water Environment Climate Change, Natural Resources and Energy towards supporting recruitment of town cleaners for Wamba, Archers and Baragoi.
- 2. Re-allocation of budget amounting to Ksh.8million from Land and Urban Planning Department to the department of Water Environment Climate Change Natural Resources and Energy for procurement of Waste transfers stations for sub-county towns. The mandate of land and urban planning department through the municipality and solid waste management is limited to Maralal town municipality.
- 3. That in reference to the later program coordinator National Program Implementation Unit (NPIU) Financing Locally Led Climate Action (FLOCCA) program by H.E Lati Lelelit regarding commitment by the County Government. Of Samburu to allocate funds towards the FLOCCA program at a tune of 41.5million as a marching fund the committee recommends priority of the wards which had programs in the utilization and implementations of the FLLOCA program.
- 4:2 Infrastructure support towards VTCSIS that the committee recommends improved infrastructure program that is centered towards improving access quality of learning on vocational training centers they include as shown in the tabulating in page 28.
- 5:0 Ward Projects Mr. Speaker Sir the committee recommends developments in the following ward projects in the FY 2023/2024 per ward in the spirit of enhancing equitable developments ward fund a total of 23 hundred million the projects are listed in the table below table 6 ward fund priorities Pages 29,20,30,31,32,33,34.

MCA Loosuk Ward, (Hon. Mr. Speaker Sir, it should be noted the spirit of devolution when it came it required that this money Exchequer from the should be shared equitably across the boards Mr. Speaker Sir, I rise here on an issue of one department having all the allocation in one ward. If you just look for those with this budget just look at the department of Lands you find that out of 94 million of the funds allocated for development 98 million want to one ward Maralal ward and Maralal ward is just under World Bank Project Municipality so it is hard here to maybe explain the reason as to why this department allocated funds to one Ward Mr.

Hon. Speaker sir, if I can use my ward as an example Loosuk Town had its planning done some 10 years ago they did planning they did beaconing the only thing remaining is validation of the Planning report and I think validation only requires 5 or 4million so after demarcation maybe all the people who were not registered in group ranches in Loosuk went and bought plots in Loosuk Town God willing maybe in some short time we will be having tarmac road from Maralal to Loosuk.

I don't understand even this department has not taken into consideration validating the planning report of Loosuk Ward so Mr. Speaker sir I rise to raise the concern am the vice chair of this department it's so unfortunate that we never captured it in the report its very bad that we have one department having the allocation in one board and I don't think it's in the spirit of devolution that this equitable share should be even shared equitably here that in all ward we should be having activities spread across all the wards in every departments so let me for today say that and I think in future as a committee we should take into consideration. Thank you.

MCA Suguta Marmar Ward, (Hon. James Leleruk): Mr. Speaker Sir first I would like also to congratulate all members of Budget Committee, staffs for and also your office as a committee we

would like to say we love our County and we want it to go forward and the concern that that my brother Hon. Lenamparasio has raised we also have those concerns but I will put a suggestion That the first supplementary that we undertake is on the land issue because every ward has a town and urban centers are growing if need be balancing must be done so we didn't want to bring a lot of issues on this budget but because we have it as a concern we will raise it later Thank you Mr. Speaker.

The County Government holds intrans of the locals has to be delivered to the communities and my ward of Nyiro is also affected and that is why I called the committee on land and the Hon House that on our first County Government supplementary we look into this matter and spread the services of the land department equitably where actually it is needed we respect actually maybe there were some issues that has informed but I cannot call it unfair yes but actually it is not really representing as a committee we regret this but we promise to revisit the issue in our first supplementary if the House actually conquer and agree with us.
