Speaker, I stand to accept the request from the Chairperson that they have the response but they want all the Members of the 15 Wards to go through and see whether the information given by the Department is true and then they bring the response tomorrow. Hon. Speaker I accept that.

Temporary Speaker, (Hon. Lenamparasio Caunda): Hon. Members, I direct that the statement No. 01/2023 requested by Special Elect; Hon. The Minority Leader, (Hon. Leleruk James): Thank you Mr. Speaker, I rise to respond to the matter raised by Hon. Leitoro Jeremiah; Member of County Assembly for Elbarta Ward through the Chairperson Sectorial Committee Education and Vocational Training regarding the status of Ward Development Fund bursary for the Financial Year 2022/2023, the Members seeks the following:

The third question asked by the Hon. Member is; "when will the Department disburse the remaining balance to the respective Wards?" And he also asked "clarify the time line for distributing the balance for respective Wards"

The response is: due to the normal budget process, that is; formulation, approval, implementation, audit, evaluation and uploading of budget, the Department expects to distribute the balance for respective Wards thereafter, thank you for your continuous cooperation. That is the end of the statement

MCA El'barta Ward, (Hon. Leitoro Jeremiah): Than you Hon. Speaker, I wish to take this opportunity to thank the Minority Leader on behalf of the Committee on Education and Vocational Training for the elaborate response. Hon. Speaker, I however need some clarification on bursary disbursement for the Financial Year 2022/2023 because I do not understand the reason as to why every Ward has been given some amount and there remains a certain amount in balances.

To my understanding, I know once Budgetary allocation has been done and when the approval is usually done it is approved for the whole amount, we approve for all of them. You do not approve and then thereafter you get half of what has been budgeted for.

Pertaining to the last Statement on the last question which was when will the Department distribute the remaining balance to the respective Wards and the Department to clarify on the timeline for distributing the remaining balance for respective Wards, I think it is now on record that the Department has said due to the normal budgetary process that is formulation, approval, implementation, audit, evaluation and uploading of Budget, the Department expects to distribute the balance for respective Wards thereafter.

My concern Mr. Speaker is which Budgetary process are we talking again because I believe the Bursary in question is for the Financial Year 2022/2023, and if the normal budget process is incomplete then where did they get this other half amount that has already been disbursed if at all the normal budget process has been...because to my knowledge the 2022/2023 Budget is already over and the process is already complete but again what they are trying to say is they are trying to push this balance from Financial Year 2022/2023 to the Financial Year 2023/2024. I think that

is what they are trying to say but my question is where has the Ksh. 23,237,250 that we have budgeted and approved for the year 2022/2023 where has it gone.

We need some clarity on this because you cannot push this balance from one Financial Year to another. I do not know the applicability and what we are going to do on this issue. Maybe this money which was meant for Bursary the 23 million was used for maybe other purposes now with the knowledge that they want to push the balances to the next Financial Year of which I even doubt if you will ever get the 23 million which is the balances that is there.

I am not satisfied with the question unless the Department commits that through whatever that they have written or responded to that we will get these balances otherwise I think that we will be taken around circles and we will never get this money. I give an example in Elbarta that whatever I received that is the total Budgetary amount was three million and I received 1.389. Because of the number of applicants there were a number of applicants who were many, the high school including those in colleges, those in tertiary institutions I ended up issuing the 1.38 to high school because they seemed in need of this money then I left the rest for those in tertiary institutions, colleges and Universities with the hope that I will get these monies because they used to tell us that you will get them in two weeks which turn into months and now we are almost in another Financial Year.

The question is what am I going to tell these students who are in tertiary colleges and Universities because I have been telling them that we wait for the balances so that we are going to disburse. This is now proving to be a story. Someone is taking us round and round.

I do not know what we are going to do on this issue because it is quite clear that the Ksh23,237,250 because this balance is supposed to be in the bursary account but we also need to request again to know what is the balance currently in the Bursary account because this Ksh23,237,250 is supposed to be in the account if this is the kind of response that they give us it seems that the account is almost empty or it does not reflect the true balance here.

It seems that the money has been used in other ways and maybe the Department is trying as much as possible to find ways to get these monies and the only way that they can be able to get this money is pushing this plan to this Financial Year which is 2023/2024 of which I do not think

that it is in order with the Controller of Budget because whatever you have budgeted you have to utilize them and you are not supposed to relocate funds that is meant for one project to another.

I think that we are doing something that is not legally right, we need to investigate further and know exactly what happened to this money because 23 million is not a small amount of money, we need to be serious, investigate and know exactly what happened to these balances, thank you Mr. Speaker.

MCA Wamba West Ward, (Hon. Lemartile Francis): Thank you Mr. Speaker. The Department did a good job in giving a response to question one and two, they have given us Ward Fund for Bursary on 2022/2023 to be 41 million and the second question is clear that it is too shocking because this is an amount which is budgeted and approved, it is termed as an item and it is shocking because at the end of the Financial Year it is less than 50% disbursed and the Department are not clear because this is not a small amount to take it lightly because 23 million taken to unbudgeted activity.

It is extremely the highest financial mismanagement Mr. Speaker. They must have something fishy or they hide something because this was exactly amount allocated by Hon. Members and they have pledged to students in their Wards to pay that amount to assist the students in their Wards. We have made pledges and at the end of the Financial Year we are told that the allocated amount is not there without even prior communication to us that the money has been reallocated to another project. As the Hon. Member who requested the Statement this Bursary thing should be investigated further because we know that there are so many irregularities there.

As the Member who asked the Statement I think we forgot to ask for bank statement for that account because it is independent and we need to interrogate it further since the time for the interception of the Committee on August last year and this year because there must be something fishy going around within that financial entity.

Secondly, the accounting officer gave a response that I do not know if it irresponsible because as he has said that the normal budget process we know that the budget process has timelines, he should also give us his timeline because if he wanted a month or two months before that he could have put it there so that we question him on that time; Mr. Speaker that question was not well

elaborated on timeframe. The Budget process is timely we know there are preparations of budgeting process, formulation, approval which was done but the only thing pending is uploading and it is less than a weeks' time. He should also give us the timeline on when is he expecting to give the Hon. Members their balances if it would be there or less we can say that it seems he does not know whether he will give the Hon. Members their balances or not, thank you Mr. Speaker.

MCA Ndoto Ward, (Hon. Lealmusia Ali): Thank you Hon. Speaker for giving me this opportunity to say something on this particular response as far as our bursary allocation is concerned. First and foremost, I would really like to thank the honorable member for Elbarta for asking this question. However, I am really not satisfied with the response from the department. This bursary is meant for students who are not capable of paying school fees for that matter in every ward. This is the only present as members of this honorable house that we can give to our ward residents.

Mr. Speaker, we are aware that as far as the finance management act is concerned, the normal government regulation is that we run through a budgetary process where we go for one financial year. We are dealing with this financial year 2022-2023 and what I expected the department to really tell us is that we already have a pending bill because under normal circumstances we clear bills first before we do other things in the normal financial management. This one has not been even reflected as a pending bill; which means this money is not even there in the first place because this response is talking about the normal budgetary process. This money was already allocated in 2022-2023 financial year.

It cannot be transferred unless it is reflected as a pending bill and they are ready to pay. That is what we have been telling our people that because it was not possible for them to process all the payments we were going to pay that as a pending bill. Unfortunately, we are told of formulation and implementation of audit are holding the budget and so many other things. We do not want to hear these stories. Let me be very sincere, we are dealing with kids who are really needy and we cannot accept this kind of answers.

What we should be told is we have a pending bill of the balance that is Kshs. 23,237,250 which we will be able to pay as a first payment not as something that is going to be formulated; formulated from where? And we are aware that this committee has been having a problem. There is a member from my ward who was appointed to this committee but he resigned because of a problem in that particular section.

Therefore, we should be serious on this because if we not going to...how come in other wards there was no reimbursement? I mean there was no disbursement? Why? I am very sure even the honorable members had given them the lists and lists are lying there. So, what are we saying here? We do not want in this house a situation where a department decides on what to do with our ward fund. We already gave them what they need.

We attached the lists, we liaise with the village admins they give us the list or we have other ways of doing it and we give them the lists. There is no way you can come and tell us here that we are formulating a budget. They have to be very clear whether it is going to be a pending bill because what we know is that pending bill is going to be paid or to be cleared in the first place even before anything else is done in the department.

The department should be clear and tell us whether this is going to be treated as a pending bill or that money is not there so that we can be able to investigate. Mr. Speaker Sir, I would suggest that we engage this committee on education to go back and give us the reality of these balances because we are really in need and we have pending lists lying there to be cleared. Thank you, Mr. Speaker.

Specially Elected MCA, (Hon. Lenamatiyo Silapia): I also stand and thank the honorable member for El'barta Ward for seeing that it is important to bring this statement and ask for the bursary remaining for the year 2022-2023 on ward fund sites. Honorable Speaker, looking at the response of the last question, we talking the budget of 2022-2023. What are they telling us? The waiting for the uploading of the current budget 2023-2024. I am also a member of the budget committee and I did not see anywhere the pending bill for bursary allocation of the year 2022-2023.

Honorable Speaker, we want this house to be respected. What you bring to this house let it be out of respect. Because you cannot tell us that we are waiting for the budget process what we have not budgeted for. Some months back we saw some loopholes in the bursary issues raised even in social media. I think that that is where the remaining balance went. There is need to investigate that department of bursary.

This is a very serious issue. We want the committee to go back and bring a very comprehensive answer to this house. I really understand the issues that our students are going through in our schools. They are chased away from school to come look for fees and we have put a budget a budget to make sure that our students remain in school. The department is not even able to tell this house where the Kshs.23M is. This one is a very serious matter.

I understand that you also represent Loosuk Ward and you have a remaining balance that has not been distributed to the students. I know your ward is going through a lot of challenges of insecurity and even our students are affected by that issue. Honorable Speaker this is a serious matter and I want to tell honorable members of that committee to go back and find out whether there is that money or not. Simple. So that we can know where this money went and if the department used that money in another project let them explain to us. I stand and direct the honorable members to go back to the department put on toes those who are responsible for this.

Specially Elected MCA, (Hon. Nakinyi Jane): Thank you Mr. Speaker. I also thank the honorable member for El'barta Ward for bringing this point onboard so that we discuss and see the issue where it is. It is really wanting and we cannot comprehend what is really the comment of the officer who answered the statement about the bursary. For sure, this is not the right thing, especially when you see the three sentences that culminates or sum up the whole results of this bursary that is not clear which is embarrassing also to our members.

So, what I urge the Honorable House, this is what we are supposed to do to come up with such things because if we stay in darkness, we will not know what is going on, for sure this is not right even in that statement its really leaving us in a hanging situation because if somebody says that the balance for the respective wards thereafter what does it mean? Which means he is

undermining the House, he is not clear with the point of what we really want, he's giving us figures which are not pleasing at all.

So, Honorable Speaker, I urge Honorable Members for Education Committee also to be serious because when we discuss matters of education here, we don't see turn up, I don't whether you have noticed, we have been bringing many things for education and we are struggling to answer up for ourselves, we don't know what is happening with the Committee, so for this let us take caution on that because there must be loopholes somewhere. Thank you, Mr. Speaker sir.

Temporary Speaker (Hon. Lenamparasio Caunda): Honorable Members, having listened to most of you or all of you who have spoken, it's my time now to direct. The first and the second questions were well answered that's according to me because they were just self-explanatory, they were just figures, but the third question, is not satisfying so, pursuant to Standing Order number 145 (1) C, I refer this statement, the third question only back to the Committee, the chairperson Education and Vocational Training Committee and bring the response to this House on August 1st at 2.30 pm. Kindly, we will not refer this statement back to you anymore, that will be last time that we are referring the statement to Education. So, Honorable Minority Leader, standing to represent the chairperson of Education be guided. Thank you.

Stacy Nareyo): Thank you Mr. Speaker as you are all aware Samburu County has been leading with teenage pregnancy Country wide and nationally the adolescence Pregnancy is leading at 15% while Samburu County has been reported to be leading with 50% this is a very serious issue that I feel it will be addressed with immediate effect the County government should come in to create awareness and to sensitize on the issue since sensitization it will affect our level of education and increasing the poverty level, I would also

I request your support as a member of women caucus from this House we need your support and the support of our elected Hon. Members to support the women caucus of this County Assembly of Samburu to have ward fund also we would like to request the affected wards our Government to build the rescue centers in the affected wards for our girls to be rescued thank you Mr. Speaker.

Temporary Speaker, (Hon. Lenamparasio Caunda): Thank you Hon. Rebecca I think before we proceed I just wanted to advice the mover of this Motion Hon. Stacy that kindly just go through your resolutions just keenly look at the first one that reads that the County Executive Committee Member in charge of Early Childhood and Vocational Training and Culture Sports and Social Services to take measures and cub the early pregnancies within the primary and secondary schools.

Ensure that doctors test students every year so as to identify early pregnancies in our children in institutions and stop further death through abortion and dropout it should be well noted that County Government only deal with early childhood centers and vocational trainings and you
