**MCA Elbarta Ward** (hon. Lempei Peter): Thank you, Mr. Speaker. I rise to support the Motion by the Majority Leader hon. Lentukunye on adjourning the house so that we can have some time to go back to the electorate and listen to them, work with them as we work on a formula and get more information on what we will be putting before this Assembly.

The purpose of an adjournment is always to let the elected Members go back to the electorate and do other duties beside a small recess to rest after a lot of work that has been going on when the Assembly is in session. So Mr. Speaker, it would be important for us to always get back to the electorate and also have some time to rest.

That is usually a reality check of the things that had been going on in the House and is also a reality check to confirm things that had been happening on the ground in that period. Ten days is

not a lot of time; much as we know we have a lot of business before us, we would want to go back to our people and have a little time with them and then come back to the session when we are more re-energized and refreshed so that we are able to discharge our mandates properly and with a lot of focus.

Indeed, I would join the Majority Leader, I would join hon Leshoomo in urging all our Members to accept that we have some time to get back to the electorate and to reflect and do a reality check of the businesses we have been conducting in the House. Mr. Speaker, I beg to support.

**MCA Wamba West Ward**, (Hon Benjamin Leitore): Thank you Mr. Speaker. Mr. I also stand to support the Motion. The Appointment Committee has received two proposed names of County Public Service Board members. If you keenly look at our calendar before it is altered, the law says that when the names are forwarded by the Governor the Assembly has 21 days to vet and subsequently approve or disapprove the names.

The leadership of this house found it necessary to alter the calendar in order to allow the Committee to come back in time, vet the two proposed individuals and consequently forward the names to the Assembly. If the calendar is not altered this will elapse by 21<sup>st</sup> or 23<sup>rd</sup> of July, meaning it will be time that this will be preparing itself for a recess. So it is appropriate for us to alter the calendar in order to give this House a chance to exercise its mandate or to perform the role of representation as required by the County Government Act and the Standing Order of the Honorable Assembly.

I support the motion as proposed by the Leader of Majority and call upon other members to support the motion. Beside other very important reasons of giving members a bit of time to interact with our electorates, to go back to our wards, I am sure we have a number of issues we would wish to get addressed, particularly for the member for Maralal Ward, my colleague is very busy in Maralal town so giving him a week to interact with his people will be a great opportunity and particularly to DC part hon. Speaker. So Mr. Speaker I support the motion that this house has a short break in order to have itself come back and execute the mandate of the House. Thank you, Mr. Speaker.
