#### COMMUNICATION FROM THE CHAIR

#### ADJOURNMENT TO ALLOW MEMBERS ATTEND LEGISLATIVE SUMMIT

**The Speaker,** (Mr. Lempere Solomon): Honorable members, I have communication to make to the house. Today is 17<sup>th</sup> May 2018 and this house is going to adjourn until the 4<sup>th</sup> of June this year for a two-week recess period. We have things that are piling up for us. We have a retreat for the legislative summit in Mombasa next week and members must attend. We also have a pending budget that needs to be approved by June and we will have to do a public participation within that period.

We also have some pending bills. We have the health services bill, the trade bill, the spatial planning bill which need to be taken through public participation and members will have to sit immediately after the legislative summit to deliberate and agree on when the four pending public participation bills need to be done. Those are bills that need this house approval within the next one and half months and I call for your cooperation in trying to ensure that we do all these within the stipulated time. You all know that the budget is guided by the PFMA act and has its own timelines before the appropriations bill is passed in June 30<sup>th</sup> of this year.

So I call for your cooperation and I call for members to attend the legislative summit. We will have all members of county assemblies in the country at the Pride Inn Hotel. I call for your cooperation, let's try to be a team as we go there. Let's present all the issues that we have to the leadership of this country. Let's try to do that within the stipulated time.

On the team that is going to Nanyuki, we'll proceed to Nanyuki then to Nairobi in preparation for the travel on Sunday to Mombasa. Let's be a team and have some coordination. The whips are there, the head of the welfare team is also there and the leadership of the house is there. There are two teams; one in Nanyuki and another in Nakuru. We will all converge in Nairobi for the travel to Mombasa. Otherwise, thank you so much. That is the communication I had to the house. Next order.

#### CONFERMENT OF MARALAL TOWN TO MUNICIPALITY STATUS

**Leader of Majority**, (Hon Lentukunye Christopher): Thank you Mr. Speaker. That pursuant to the provisions of section 9(1) of the Urban Centres and Cities Act 2012, this assembly

approves the conferment of municipality status to Maralal town following the grant of a charter by the governor that was tabled in this assembly on 15<sup>th</sup> May 2018. Thank you, Mr. Speaker.

**The Speaker,** (Mr. Lempere Solomon): Hon. Members, I now propose the question that pursuant to the provisions of section 9(1) of the Urban Centers and Cities Act 2012, this assembly approves the conferment of municipality status to Maralal town following the grant of a charter by the governor that was tabled in this assembly on 15<sup>th</sup> May 2018. Members can proceed to contribute. Hon Leshoomo.

**MCA Lodokejek Ward,** (Hon. Jerias Leshoomo): Thank you, Mr. Speaker. I stand to support the motion on the conferment of municipality status to Maralal town. Mr. Speaker, section 8 of the Urban Areas and Cities Act empowers the county governor to upgrade the status of a town to a municipality after the town has got some justification for the upgrading. I think under the resolution of the County assembly passed the governor's act. I think it is in order, Mr. Speaker, for us to support the approval so that our town can get the status of a municipality.

I think if we get the municipality status in this town, the services will also improve since it will have its own management and not under the county government. So I think upgrading the Maralal town to a municipality will help the residents of this town in service delivery if it gets better administration. Thank you, Mr. Speaker.

**MCA Maralal Ward,** (Hon Kiragu Fred): Thank you very much, Mr. Speaker. I rise to support that Maralal town be granted municipality status. I do not know how that will affect me politically because it might if those votes from Nauneri and Seketet and Lemisigiyo will matter in this for electing the MCA for Maralal town but all said and done, let the best win. That cannot hinder us from seeking development. I am aware that the World Bank is granting Ksh. 50 million to Maralal town for development befitting a municipality status and if this house fails to pass this motion then we shall lose Ksh. 50 Million. It is a lot of money in any language and that money is going to put this town like most of the other towns in this country.

I know and everybody in this honorable house knows that this town has lagged behind for very many years and this house should not be an instrument that is going to stop further development of this town. So, I support this motion and support it fully so that this town moves to that municipality status. In fact, when I was a councilor before 2007, this town was supposed to be a municipality; we went visiting very many local government ministers to give this town a municipality status and we didn't succeed. Now that God has brought it in his own way, I support the motion. Thank you, Mr. Speaker.

The Speaker (Mr. Lempere Solomon): Hon. Antonella Lobura.

**MCA** (Hon Lobura Antonella): Thank you, hon. Speaker. I rise to support the motion. Ugrading this town to a municipality is of great help to our county. Getting this grant will improve most of the services in our county. Look at the drainage system in the town, it is very poor and getting this grant will improve most of the services. Again, if you see the roads, especially those behind the town, they are poor. Getting this grant will help improve most of the feeder roads into better roads.

On the parking lots for cars, getting this grant will help in generating revenue in our town. If you see these cars, motorbikes and taxis they are parked anywhere and there's no revenue being collected, lowering the county revenues. So, I support the motion. Thank you.
